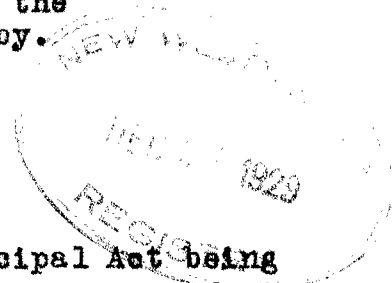


CORPORATION OF THE DISTRICT OF BURNABY.

BY-LAW NO. 1004.

A by-law to provide for the appointment and method of appointment of officers of the Corporation of the District of Burnaby.

WHEREAS by Section 50 of the Municipal Act being Chapter 179 of the Revised Statutes of British Columbia 1924, the Council may by by-law provide for the appointment and method of appointment of officers of the Corporation to fill or occupy such positions as may from time to time become vacant, or such positions as may be deemed necessary or expedient for the carrying-on of the good government of the Municipality;

AND WHEREAS the officers of the Corporation of the District of Burnaby are those hereinafter mentioned and it is desirable to confirm them in their several offices and to provide for the filling of any vacancy which may hereafter occur;

THE MUNICIPAL COUNCIL of the Corporation of the District of Burnaby enacts as follows:

1. The following officers of the Corporation of the District of Burnaby are hereby appointed and confirmed in their several offices, namely:

2. The Council may by resolution fill any vacancy among the officers of the Corporation which may from time to time occur and appoint other officers as may be deemed necessary or expedient for the carrying-on of the good government of the Municipality of Burnaby, and the carrying out of the provisions of the Municipal Act, and fix the salary or remuneration of officers.

3. All by-laws heretofore passed by the Council for the appointment of officers are hereby repealed.

4. This by-law may be cited as "MUNICIPAL OFFICERS APPOINTMENT BY-LAW 1929".
