

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1005.



A BY-LAW to authorize the sale of certain lands acquired by the Corporation under tax sale proceedings and to accept in part or full payment other lands in the Municipality owned by Arthur Harold Miller.

WHEREAS the Corporation has acquired under Tax Sale proceedings the lands and premises known and described as Lot Forty-three (43) of (12. & 12.16 Acre part) of District Lot Eighty-five (85), Group One (1), Map numbered 1866.

AND WHEREAS Arthur Harold Miller of 615 Pender Street West, in the City of Vancouver, and the Province of British Columbia, is the registered owner of the lands and premises known and described as Block Fifty (50), of District Lot Eighty-three (83) Group One (1), Map No. 1267, New Westminister District.

AND WHEREAS the said Arthur Harold Miller has requested the Corporation to convey to him the said lands so acquired by the Corporation under Tax Sale proceedings and to accept in full payment therefor a conveyance of the said lands and premises owned by the said Arthur Harold Miller together with the sum of Ten (\$10.00) Dollars.

AND WHEREAS the Council deems it expedient to effect such exchange of lands.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby enacts as follows:-

(1) Upon the execution and delivery to the Corporation by the said Arthur Harold Miller, of a good and sufficient Deed in Fee Simple of Block (50)

of District Lot Eighty-three (83), Group One (1), Map No. 1267 free and clear of all encumbrances whatsoever, together with the sum of(\$10.00) Ten dollars, the Reeve and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a conveyance of said Lot Forty-three (43), of (12 & 12.16 Acre Part) of District Lot Eighty-five (85), Group One (1), Map numbered 1866, to the said Arthur Harold Miller.

(2) This By-law may be cited as "Burnaby Property Exchange By-law No. 7. 1929."

DONE AND PASSED in Open Council this Thirtieth (30th) day of December, A.D. 1929.
