

CORPORATION OF THE DISTRICT OF BURNABY.

BY-LAW NO. 1034.

A BY-LAW to fix the date the Collector shall add percentage additions to the current year's taxes unpaid on each parcel of land upon Collector's Roll for the District of Burnaby.

WHEREAS Section 241 of the "Municipal Act" being Chapter 179 of the Revised Statutes of British Columbia 1924, provides as follows:-

"(1) Upon the first day of July in each year the
"Collector shall add to the current year's taxes
"unpaid on each parcel of land or improvements
"upon his roll ten per centum of the amount thereof,
"and upon the first day of October in each year
"shall add an additional amount of five per centum
"thereof, and the said unpaid taxes, together with
"the amounts added as aforesaid, shall from the
"respective dates aforesaid be deemed to be the
"amount of current year's taxes due upon such land
"or improvements."

"(2) The Council may, by byelaw to be passed prior
"to the transmission of the notices under Section 237,
"alter the dates upon which percentages shall be added
"or the amount of the percentage to be added, or may
"specify that a percentage be added on one date only;
"but so that the percentage or aggregate of percentage
"to be added prior to the thirty-first day of December
"shall be fifteen per cent. of the amount of the tax
"imposed."

AND WHEREAS it is deemed advisable to alter the date upon which the percentage aforesaid shall be added.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby enacts as follows:-

1. Upon the first day of July, 1930, the Collector shall add to the current year's taxes unpaid on each parcel of land or improvements upon his roll five (5) per centum of the amount thereof, and upon the first day of August, 1930, shall add an additional amount of five (5) per centum thereof and upon the first day of September, 1930, shall add a further additional amount of five (5) per centum thereof and the said unpaid taxes together with the amounts added as aforesaid shall from the respective dates aforesaid be deemed to be the amount of current year's taxes due upon the said land and improvements.

2. This By-law may be cited as "BURNABY PERCENTAGE ADDITIONS BY-LAW, 1930."
