

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1090.

A BY-LAW to define and set aside certain lands within the Municipality of Burnaby for Park purposes.

whereas by paragraph "D" of sub-section 175 of Section 54 of the "Municipal Act" it is provided that in every Municipality the Council, may, by by-law finally passed by a three-fourths vote of all the members thereof, and without obtaining the assent of the electors, define an area comprising lands that have become the property of the Municipality through tax sale proceedings and set aside such area for park purposes, for recreation grounds, or school sites, or for other public purposes.

AND WHEREAS it is considered expedient and in the public interest that the hereinafter mentioned lands in the Municipality of Burnaby should be so set aside.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby ENACTS as follows:-

1. There is hereby defined and set apart for park purposes all of the lands comprised in the following viz:Lot Seventeen (17) Subdivision of Lot Three (3) of District
Lot Seventy four (74) South half, Group One (1) New Westminster
District, according to Map Numbered 1380. Lots Sixty three a
(65a), Sixty four a (64a) of Lot Eighteen (18) in subdivision
of Lot Three (3) of District Lot Seventy four (74) South half,
Group One (1) New Westminster District, according to Map
numbered 1874. Lots Forty three a (43a), Forty four a (44a)
Forty five a (45a), Fifty a (50a), Fifty one a (51a) and
Fifty two a (52a), of subdivision of Lots Nineteen (18)
to Twenty (20) inclusive, Subdivision Three (3) of District
Lot Seventy four (74) South half, Group One (13) New Westminster
District, Map numbered 1852. Lots One (1), Two (2), Three

(3) and Four (4) of Lot "N" of Lot Twenty (20), in Subdivision of Lot Three (3), of District Lot Seventy four (74) South half, Group One (10, New Westminster District, according to Map numbered 4313.

2. This By-law may be cited as "BURNABY PARK DEDICATION BY-LAW 1930."

RECONSIDERED and FINALLY PASSED by a three-fourths vote of all the members of the Municipal Council on the Fifth (5th) day of May, A.D. 1930.
