

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1109.

A BY-LAW to authorize the exchange of certain lands acquired by the Corporation under Tax sale proceedings for certain other lands owned by Albert Henry Lowe and Dorothy Lowe.

WHEREAS the Corporation has acquired under Tax Sale proceedings the lands and premises known and described as Lot Fifty five (55) in subdivision of Lots One (1) to Twelve (12) inclusive of Block One (1) District Lot Seventy four (74) South half, Group One (1) Map No. 1547 deposited in the Land Registry Office at New Westminster, Province of British Columbia.

AND WHEREAS Albert Henry Lowe and Dorothy Lowe, wife of Albert Henry Lowe, both of 1727 William Street in the City of Vancouver, Province of British Columbia, are the registered owners of the lands and premises known and described as Lot Eleven (11) of Block One (1) District Lot One hundred and fifty (150) Map No. 2041 deposited in the Land Registry Office, New Westminster, Group One (1) New Westminster District.

AND WHEREAS the said Albert Henry Lowe and Dorothy Lowe have requested the Corporation to convey to them the said lands so acquired by the Corporation under Tax sale proceedings and to accept in full payment therefor a conveyance of the said lands and premises owned by the said Albert Henry Lowe and Dorothy Lowe.

AND WHEREAS the Council deems it expedient to effect such exchange of lands.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby ENACTS as follows:-

1. That upon the execution and delivery to the Corporation by the said Albert Henry Lowe and Dorothy Lowe of a good and sufficient Deed in Fee simple of Lot Eleven (11)

Block One (1) District Lot One hundred and fifty (150) Group One (1) New Westminster District, according to Map No. 2041, deposited, free and clear of all encumbrances whatsoever the Reeve and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a Conveyance of said Lot Fifty five (55) subdivision of Lots (1) One to Twelve (12) inclusive, of Block One (1) District Lot Seventy-four South half (74S $\frac{1}{2}$) Group One (1) New Westminster District according to Map No. 1547, deposited, to the said Albert Henry Lowe and Dorothy Lowe and to deliver such Conveyance when so executed to the said Albert Henry Lowe and Dorothy Lowe.


2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY- LAW NO. 3. 1930."


