CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1186.

A by-law to amend the "Burnaby Waterworks Regulation By-law No. 2, 1926".

THE MUNICIPAL COUNCIL of the Corporation of the District of Burnaby ENACTS AS FOLLOWS:-

1. Section 4 of the "Burnaby Waterworks Regulation By-law No. 2, 1926" being By-law No. 521 of the Corporation of the District of Burnaby is hereby repealed and the following substituted therefor:

"4. In any case where an application may hereafter be made for the extension of any water main, the applicant or applicants shall, before the application is considered by the Council, pay to the Municipal Treasurer the full cost of service connection and in addition thereto water rates in advance in the amounts set out hereunder, that is to say:-

2. This by-law may be cited as "BURNABY WATERWORKS REGULATION BY-LAW NO. 2, 1926, AMENDMENT BY-LAW 1930".

3. This by-law shall come into force upon receiving the approval of the Lieutenaht-Governor in Council.
