Be It Therefore Enacted by the Municipal Council of the Corporation of the.....

- 1. That the said Corporation be and it is hereby authorized to borrow from THE ROYAL BANK OF CANADA the sum of **Cne hundred and sixty five** thousand [ \$165,000] ollars.
- 2. That the said Corporation be and it is hereby authorized to pay to the said Bank interest on the said sum of <u>Cne hundred and sixty five thousand</u> Dollars at the maximum rate of <u>Six</u> (<sup>6</sup>%) per centum per annum, which may be paid or allowed in advance by way of discount, or otherwise howsoever as they may deem best

- 4. That the obligation to be given therefor shall be a Promissory Note signed by the Mayor or Reeve and Finance Committee, and the Clerk of the Corporation, and shall bear the Corporate Seal of the Corporation, and shall be for a period not exceeding one year, but may be renewed from time to time as circumstances may require.
- 5. There is hereby set aside as security for the payment of such money with all interest thereon respectively, the whole of all unpaid taxes assessed and levied in the said District, as shown in the Schedule to this By-Law.
