## CORPORATION OF THE DISTRICT OF BURNABY

## BY-LAW NO. 1261

A BY-LAW to emend the "Burnaby Waterworks Regulation By-law No. 2, 1926."

THE MUNICIPAL COUNCIL of the Corporation of the District of Burnaby enacts as follows :-

1. The Burnaby Waterworks Regulation By-law No. 2, 1916, being By-law No. 521, of this Corporation, is hereby amended by cancelling the schedule "A" attached thereto, and by substituting therefor the Schedule attached to this By-law.

2. This By-law shall come into effect on the 30th. day of June, A.D. 1931.

3. This By-law may be cited as the "BURNABY WATERWORKS REGULATION BY-LAW NO. 2, 1926 AMENDMENT BY-LAW 1931."
