CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1272

A BY-LAW to acquire lends within the Municipality of Burnaby.

WHEREAS under the provisions of Sub-section 30 of Section 54 of the Municipal Act the Municipal Council is authorized to make and pass By-laws to acquire lands.

AND WHEREAS it is desirable and expedient that a portion of Block 3, District Lot 153, Group 1, District of New Westminster, Province of British Columbia should be acquired.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby enacts as follows:-

1. A portion of Block 3, District Lot 153, Group 1, District of New Westminster, Province of British Columbia according to Plan 783, deposited, and being more particularly described as follows:-

COMMENCING at a point on the Northerly Boundary of Block Three (3) aforesaid, located 17.0 feet, N. 68* 49' 40" W., from the Northeast Corner of said Block 3;

thence N. 68° 49' 40" W. and following the Northerly Boundary of said Block 3, 31.43 feet to a post;

thence S. 35° 08' W. and parallel to the Southeasterly Boundary of Block 3, aforesaid, 513.0 feet to a post set on the Northerly Boundary of Kingsway;

thence S. 63° 15' 30" E. and following the Northerly Boundary of Kingsway, 30.83 feet to an intersection with the Westerly Boundary of Willingdon Avenue (Guichon Road) as Gazetted on November 7th, 1896;

thence N. 35° 08' E. and parallel to the Southeasterly Boundary of Block 3, aforesaid, 516.08 feet to the point of commencement, and containing, by admeasurement, 0.360 of an Acre, be the same more or less, as shown on the plan hereunto annexed and thereon outlined with red colour,

shall be acquired

from the Old Orchard Auto Camp Limited, of 4125 Kingsway, in the Municipality of Burnaby, and Province of British Columbia, for Corporate purposes.

2. On execution and delivery of Conveyance by the said Old Orchard Auto Camp Limited, of 4125 Kingsway, in the Municipality of Burnaby, and Province of British Columbia, to the Corporation of the District of Burnaby, they shall be paid the sum of Six hundred and thirty one dollars and eighty cents (\$631.80)

3. This By-law may be cited as the "WILLINGDON AVENUE PROPERTY FURCHASE BY-LAW 1931."
