HY-LAW NO. 1326.

A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby.

WHEREAS at the Tax Sales held by the Collector of Burnaby for the years 1917, 1918, 1919, 1920, 1922, 1924, 1928 and 1929, the lands described in the schedules marked "A", "B", "C", "D", "B", "G", and "H" herete annexed became the property of the Corporation of the District of Burnaby in default of other purchaser.

AND WHEREAS the person named in the several Schedules marked "A", "B", "C", "D", "F", "G" and "H" hereto annexed has offered to purchase the lands set opposite his name in the said Schedules for the price named therein, AND it is advisable to accept the said offers, respectively.

THE MUNICIPAL COUNCIL of the Corporation of the District of Burnaby therefore enacts as follows:-

1. That the parcel of land set opposite the name of the purchaser in the several schedules marked "A", "B", "C", "D" "E", "F", "G" and "H" hereto annexed, which Schedules are hereby incorporated with and made part of this by-law, be sold and disposed of to the person named in the said Schedules as purchaser thereof for the consideration therein expressed.

2. That upon payment of the consideration named in the said Schedules for the parcel of land, sold, conveyance to the purchaser named in the said schedules be executed under the seal of the Corporation by the Reeve and Clerk and delivered to the purchaser. 3. "Burnaby Land Sale By-law No. 5, 1928" being By-law No. 787 of this Corporation, Schedule "C" is hereby amended by striking out Lot 17, and 18, Block 30, District Lot 121, Clydesdale, John and Clydesdale, Phyllis, 4447 Venables Street, Vancouver, B. C. \$250.00. and substituting therefor: Lot 18, Block 30, District Lot 121, Clydesdale, John and Clydesdale, Phyllis, 4047 Pender Street East, Vancouver, B. C. \$135.00.

4. "Burnaby Land Sale By-law No. 11, 1929", being By-law No. 980 of this Corporation, Schedule "C" is hereby emended by deleting therefrom the following where it appears: "West 2/3rds Lot 14, Lots 15, 16 and."

5. "Burnaby Land Sale By-law No. 6, 1930", being By-law No. 1099 of this Corporation, Schedule "A" is hereby amended by altering the word "Christie" where it appears to the word "Christer."

THIS By-law may be cited as "BURNABY LAND SALE BY-LAW NO. 5, 1931."
