

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1332.



A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby.

WHEREAS at the Tax Sales held by the Collector of Burnaby for the years 1916, 1917, 1918, 1919, 1920, 1924, 1925, 1927, 1929, the lands described in the schedules marked "A", "B", "C", "D", "E", "F", "G", "H" and "J" hereto annexed became the property of the Corporation of the District of Burnaby in default of other purchaser.

AND WHEREAS the person named in the several Schedules marked "A", "B", "C", "D", "E", "F", "G", "H", and "J" hereto annexed has offered to purchase the lands set opposite his name in the said Schedules for the price named therein, AND it is advisable to accept the said offers, respectively.

THE MUNICIPAL COUNCIL of the Corporation of the District of Burnaby therefore enacts as follows:-

1. That the parcel of land set opposite the name of the purchaser in the several schedules marked "A", "B", "C", "D", "E", "F", "G", "H", and "J" hereto annexed, which Schedules are hereby incorporated with and made part of this by-law, be sold and disposed of to the person named in the said Schedules as purchaser thereof for the consideration therein expressed.

2. That upon payment of the consideration named in the said schedules for the parcel of land, sold, conveyance to the purchaser named in the said schedules be executed under the seal of the Corporation by the Reeve and Clerk and delivered to the purchaser.

3. "Burnaby Land Sale By-law No. 1, 1926" being By-law No. 497 of this Corporation, Schedule "E" is hereby amended by deleting the word "Dickenson" where it appears and substituting therefore the word "Dickinson".

4. "Burnaby Land Sale By-law No. 5, 1931" being By-law No. 1326 of this Corporation, Schedule "A" is hereby amended by deleting the word "Margaret" where it appears and substituting therefore the word "Maggie".

5. "Burnaby Land Sale By-law No. 1, 1931," being By-law No. 1220 of this Corporation, Schedule "E" is hereby amended by deleting therefrom the following item where it appears:-  
"Lot 7, Block 22, District Lot 121, Hayes Randolph, 4340 Georgia Street East, Burnaby, B. C. \$120.00." and substituting therefor the following:- "Lot 1, Block 22, District Lot 121, Hayes Randolph, 4340 Georgia St. East, Burnaby, B. C. \$120.00."

6. "Burnaby Land Sale By-law No. 7, 1928," being By-law No. 808 of this Corporation, Schedule "A" is hereby amended by deleting therefrom the following item where it appears:-  
"Lot 7, Block 25, District Lot 69, Ellen Rogers, Ardley B. C. \$135.00."

THIS BY-LAW may be cited as "BURNABY LAND SALE BY-LAW NO. 6, 1931."
