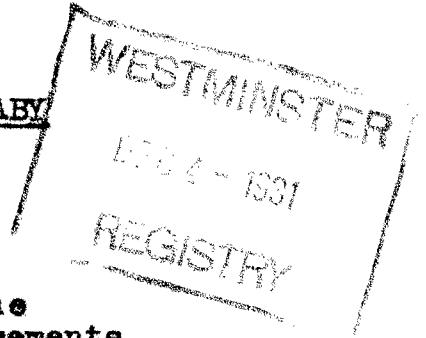


CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1348



A BY-LAW to authorize the Corporation of the District of Burnaby to acquire Easements for Corporate purposes.

- - - -

WHEREAS it is desirable and expedient that Easements should be acquired through the hereinafter described property for the purpose of rights of way for drainage ditches.

AND WHEREAS John Armstrong of 1913 Gilley Avenue in the Municipality of Burnaby is the owner of Lot 3, of Lot 11, of Block "C" District Lot 96, Group One (1) New Westminister District, Map No. 4220;

AND WHEREAS Harry D. Gale, of 1919 Gilley Avenue, in the Municipality of Burnaby is the owner in fee of Lot 2, of Lot 11, of Block "C" District Lot 96, Group 1. New Westminister District, Map No. 4220:

AND WHEREAS George Muhldorff, of 2540 Jutland Street in the Municipality of Burnaby is the owner of Lot "C" of Lot 1, of Lot 11, of Block "C" District Lot 96, Group 1. New Westminister District, Map No. 4723.

AND WHEREAS the aforesaid John Armstrong; the aforesaid Harry D. Gale; and the aforesaid George Muhldorff, have agreed to grant an easement for right of way over and through their respective properties:

AND WHEREAS under the provisions of paragraph (a) of sub-section 30 of Section 54 of the Municipal Act, the Municipal Council is authorized to make and pass by-laws to acquire or accept easements.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby ENACTS as follows:-

(1) It shall be lawful for the Municipal Council of the Corporation of the District of Burnaby to acquire an easement from John Armstrong, of 1913 Gilley Avenue, in the

Municipality of Burnaby, Province of British Columbia, for a right of way for a drainage ditch across and over ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being all that portion of Lot 3 of Lot 11, Block "C" District Lot 96, Group 1, District of New Westminster, Province of British Columbia, according to Plan No. 4220, deposited which is outlined in red colour on Plan No. 5081 deposited in the Land Registry Office at New Westminster, B.C. and containing by admeasurement 2791.6 square feet, be the same more or less, paying therefor the sum of One (\$1.00) dollar of lawful money of Canada.

(2) It shall be lawful for the Municipal Council of the Corporation of the District of Burnaby to acquire an easement from Harry D. Gale, of 1919 Gilley Avenue, and George F. Sample, of 1917 Gilley Avenue, both in the Municipality of Burnaby, Province of British Columbia, for a right of way for a drainage ditch across and over ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being all that portion of Lot 2, of Lot 11, Block "C" District Lot 96, Group 1, District of New Westminster Province of British Columbia, according to Plan No. 4220, deposited, which is outlined in red colour on Plan No. 5081 deposited in the Land Registry Office at New Westminster, B.C. and containing by admeasurement, 792.1 square feet, be the same more or less, paying therefore the sum of One (\$1.00) dollar of lawful money of Canada.

(3) It shall be lawful for the Municipal Council of the Corporation of the District of Burnaby to acquire an easement from George E. Muhlendorff, of 2540 Jutland Street, in the Municipality of Burnaby, Province of British Columbia, for a right of way for a drainage ditch across and over ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being a portion of Lot "C" of Lot 1, of Lot 11, Block "C" District Lot 96, Group 1, New Westminster District, Province of British Columbia, according to Plan No. 4723 deposited, which is shown outlined in red colour on Plan No. 5081 deposited in the Land Registry Office at New Westminster, B.C. and containing, by admeasurement, 1199.4 square feet, be the same more or less, paying therefor the sum of One (\$1.00) Dollar of lawful money of Canada.

(3) This By-law may be cited as the "BURNABY EASEMENT AUTHORIZATION BY-LAW, 1931."

DONE AND PASSED in open Council this Sixteenth (16th) day of November, A.D. 1931.
