

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1417.



A BY-LAW to acquire lands within the Municipality of Burnaby for Corporate purposes.

WHEREAS under the provisions of sub-section 30 of Section 54 of the "Municipal Act" the Municipal Council is authorized to make and pass by-laws to acquire lands.

AND WHEREAS it is desirable and expedient that portion of Lot Twenty five (25) Block Thirty-six (36) District Lots One hundred and fifty-one, and one hundred and fifty three (151/3) Group One (1), New Westminster District, Map No. 1263, should be acquired for Corporate purposes.

AND WHEREAS Clara Russell, wife of Franklin Russell of 2832 Mayne Avenue, in the Municipality of Burnaby, is the owner of the said lot Twenty-five (25) and has agreed to convey portion of the said lot hereinafter described to the Corporation for the consideration herein expressed.

NOW THEREFORE the Municipal Council of the Corporation of the District of Burnaby enacts as follows:

1. All and singular that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby and being more particularly described as the northeasterly thirty three (33) feet of Lot Twenty-five (25) Block Thirty six (36) subdivision of District Lots One hundred and fifty one (151) and One hundred and fifty three (153) Group One (1) New Westminster District, Map No. 1263 deposited, said thirty three (33) foot strip extending from the Northwesterly boundary of said Block Thirty six (36) to Willingdon Avenue, shall be

acquired from Clara Russell, wife of Franklin Russell of 2832 Mayne Avenue in the Municipality of Burnaby, for Corporate purposes.

2. That upon execution and delivery of a conveyance by the said Clara Russell free and clear of all encumbrances, to the Corporation of the District of Burnaby, she the said Clara Russell shall be paid the sum of Three hundred and two dollars and one cent (\$302.01)

3. This By-law may be cited as the "BURNABY ACQUISITION OF PROPERTY BY-LAW NO. 5, 1932."
