

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1464.

A By-law repealing by-laws number 1424, 1429, 1430, 1437, 1445.

WHEREAS on the 15th day of November 1932 and on certain subsequent dates the Corporation of the District of Burnaby borrowed from the Province of British Columbia certain sums of money under and by virtue of certain agreements entered into between the said Corporation and His Majesty The King in the right of the Province of British Columbia pursuant to the provisions of Sub-section One (1) of Section Three (3) of the "Unemployment Relief Act 1932" being Chapter 58 of the Statutes of British Columbia 1932 and pursuant thereto did pass certain by-laws authorizing the borrowing of the said sums of money

AND WHEREAS it is proposed to consolidate the debenture debt so contracted

AND WHEREAS the Lieutenant-Governor in Council by Order in Council dated the 13th day of October A.D. 1933 did pursuant to Section 467 of the Municipal Act as amended by the "Municipal Act Amendment Act 1932" appoint John Mahony, Esquire, of Vancouver, British Columbia, a commissioner for the Corporation of the District of Burnaby to have all the powers and authority theretofore vested in or exercisable by the Reeve, the Council, the Board of Police Commissioners, the Board of School Trustees, the Municipal Clerk and the other officers of the Corporation of the District of Burnaby

THEREFORE I, John Mahony, Esquire, exercising the powers and authority heretofore vested in or exercisable by the Reeve and Council of the Corporation of the District

of Burnaby as aforesaid do enact as follows:

1. By-law number 1424 being "Burnaby Unemployment Loan By-law 1932" is hereby repealed.
2. By-law number 1429 being "Burnaby Unemployment Loan By-law 1933" is hereby repealed.
3. By-law number 1430 being "Burnaby Unemployment Loan By-law No. 2, 1933" is hereby repealed.
4. By-law number 1437 being "Burnaby Unemployment Loan By-law No. 3, 1933" is hereby repealed.
5. By-law number 1445 being "Burnaby Unemployment Loan By-law No. 4, 1933" is hereby repealed.
6. This By-law may be cited as the "Burnaby Unemployment Loan By-laws Repealing By-law 1933".
