

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1491.

A BY-LAW for fixing hours for closing of Barber Shops in the District of Burnaby.

WHEREAS by Section (4) of the "Shops Regulation Act" and Amending Acts it is provided that any Municipal Council may by By-law require that during the whole or any part or parts of the year all or any class or classes of shops within the Municipality shall be closed, and remain closed on each and any day of the week at and continuously after or for the time and hour fixed or appointed in that behalf by the By-law as follows:-

(A) On any statutory legal holiday for the whole or any part of such day.

(B) On any one or more half holidays in any one week, made such by Municipal By-law, the hour for closing shall not be earlier than 12;00 o'clock noon of such day.

(C) On any other day of the week the hour fixed or appointed by the By-law for closing shall not be earlier than five of the clock in the afternoon, and the By-law shall be subject in all respects to the provisions of the "Weekly Half Holiday Act".

AND WHEREAS pursuant to Section (5) of the "Shops Regulation Act" as amended by Section (2) of Chapter 47 of the Statutes of the Province of British Columbia 1932 an application has been presented to the Municipal Council signed by not less than three-quarters in number of the licenced occupiers of barber shops within the Municipality of the District of Burnaby under Municipal licences issued in respect of those shops praying for the passing of a By-law requiring the closing of all barber shops wituate within the said Municipality at the time and hours mentioned in that behalf if the application and hereinafter set forth in this By-law.

THEREFORE the Commissioner of the Corporation of the

District of Burnaby ENACTS as follows:-

1. On Monday, Tuesday, Thursday and Friday of each and every week, all barber shops within the Municipality of the District of Burnaby shall be closed and remain closed from and after the hour of 7:00 o'clock in the afternoon until the hour of 8:00 o'clock in the forenoon of the following day.
2. On Saturday of each and every week all barber shops within the Municipality of the District of Burnaby shall be closed and remain closed from and after the hour of 8:00 o'clock in the afternoon until the hour of 8:00 o'clock in the forenoon of the Monday next following.
3. Save as hereinafter mentioned on Wednesday of each and every week all barber shops within the Municipality of the District of Burnaby shall be closed and remain closed from and after the hour of 1:00 o'clock in the afternoon until the hour of 8:00 o'clock in the forenoon of the following day. In a week in which occurs any one of the following statutory legal holidays, namely: New Year's Day, Good Friday, Victoria Day, Dominion Day, Labor Day, Thanksgiving Day, Remembrance Day, or Christmas Day all barber shops within the District of Burnaby shall on Wednesday of that week be closed and remain closed ~~from~~ and after the hour of 7:00 o'clock in the afternoon until the hour of 8:00 o'clock in the forenoon of the following day.
4. On the following statutory legal holidays, namely: New Year's Day, Good Friday, Victoria Day, Dominion Day, Labor Day, Thanksgiving Day, Remembrance Day and Christmas Day all barber shops within the Municipality of the District of Burnaby shall be closed and remain closed for the whole of such days.
5. On days next previous to the aforesaid statutory legal holidays the hour of closing shall not be later than 8:00 o'clock in the afternoon.
6. All barber shops shall be closed and remain closed each Sunday during the whole of the day.
7. Every owner, occupier or manager of any barber shop who allows, suffers or permits such barber shop to remain open during any of the times prohibited by this By-law

shall be liable upon summary conviction for each offence to a fine not exceeding Fifty Dollars (\$50.00) and costs.

8. This By-law may be cited as "BARBER SHOPS REGULATION BY-LAW 1934."

9. This By-law shall take effect on the First (1st) day of September, A.D. 1934.
