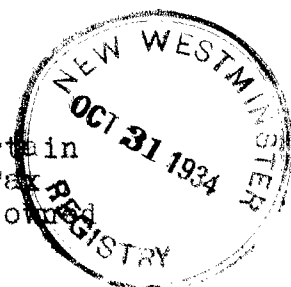


CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1493.

A BY-LAW to authorize the exchange of certain lands acquired by the Corporation under Tax Sale proceedings for certain other lands owned by Margaret Annie Borjesson.



WHEREAS the Corporation has acquired under Tax Sale proceedings the lands and premises known and described as Westerly one-half of Lot Thirteen (13 W $\frac{1}{2}$ ) of Block Thirty two (32) of District Lot Thirteen (13) Group One (1) New Westminster District, Map No. 3046;

AND WHEREAS Margaret Annie Borjesson, wife of Howard T. Borjesson, of the Municipality of Burnaby is the registered owner of Lot Seven(7) of subdivision of Lots Fifty (50) and Fifty one (51) of Block Two (2) of District Lot Ninety five (95) Group One (1) Map No. 2073, in the Municipality of Burnaby, Province of British Columbia, District of New Westminster.

AND WHEREAS the said Margaret Annie Borjesson has requested the Corporation to convey to her the said lands so acquired by the Corporation under Tax Sale proceedings and to accept in full payment thereof a Conveyance of the said lands and premises owned by her together with the sum of Ten (\$10.00) Dollars.

AND WHEREAS the Commissioner for the Corporation of the District of Burnaby deems it expedient to effect such exchange of lands:

THEREFORE, the Commissioner for the Corporation of the District of Burnaby ENACTS AS FOLLOWS:

1. Upon the execution and delivery to the Corporation by the said Margaret Annie Borjesson, wife of Howard T. Borjesson, of the Municipality of Burnaby, of a good and sufficient Deed in Fee Simple of Lot Seven (7), of Lots Fifty (50) and Fifty one (51) of Block Two (2), of District Lot Ninety five (95) Group One (1) New Westminster District, Map No. 2073, free and clear of all encumbrances

whatsoever the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a conveyance of the said Lot Thirteen West half, of Block Thirty two (32) District Lot Thirteen (15) Group One, (1), Map No. 3046, New Westminster District, to the said Margaret Annie Borjesson.

2. This By-law may be cited as "Burnaby Property Exchange By-law No.1. 1934".
