THE COMMISSIONER for the Corporation of the District of Burnaby therefore ENACTS as follows:

- of the purchasers respectively in the schedules marked "A", "B" and "C" hereto annexed, which schedules are hereby incorporated with and made part of this By-law be sold and disposed of to the persons named in the said schedules as purchaser thereof for the consideration therein expressed.
- 2. That upon payment of the consideration named in the schedules for the parcels of land sold, conveyance to the purchasers named in the said schedules be executed under the seal of the Corporation by the Co missioner and Clerk and be delivered to the purchaser.

3. This By-law may be cited as "BURNABY LAND SALE BY-LAW NO. 5. 1934."
