

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1499. *CSB*

A BY-LAW to authorise the sale of certain tax sale lands belonging to the Corporation of the District of Burnaby.

WHEREAS the Corporation has acquired under tax sale proceedings the following lands, viz: Lots (1) One, Two (2), Four (4) to Eighteen (18) both inclusive, Twenty-one (21), Twenty two (22) and Twenty three (23) of Block Thirty two (32) of District Lot One hundred and eighty-seven (187); Blocks Thirty five (35) and Thirty six (36) of District Lot One hundred and eighty seven (187) all in Group One (1) New Westminster District, Map numbered 1282; and Lot One (1) of Block "A" of District Lot One hundred and eighty eight (188) Group One (1) New Westminster District, Map No. 4169.

AND WHEREAS Dent Limited, a company incorporated under the laws of the Province of British Columbia, has offered to purchase the said lands for the sum of Twelve thousand, five hundred (\$12,500.00) dollars.

AND WHEREAS the Commissioner for the Corporation of the District of Burnaby deems it advisable to accept the said offer.

THE COMMISSIONER for the Corporation of the District of Burnaby therefore ENACTS AS FOLLOWS:

1. That the said lands, namely: Lots One (1), Two (2), Four (4) to Eighteen (18) both inclusive, Twenty one (21),



Twenty two (22) and Twenty three (23) of Block Thirty two (32) of District Lot One hundred and eighty seven (187); Blocks Thirty five (35) and Thirty six (36) of District Lot One hundred and eighty seven, all in Group One (1) New Westminster District, Map Numbered 1282; and Lot One (1) of Block "A" of District Lot One hundred and eighty eight (188) Group One (1) New Westminster District Map No. 4169 be sold and disposed of to the said Dent Limited for the said sum of Twelve thousand five hundred (\$12,500.00) dollars.

2. That upon payment of the said sum of Twelve thousand five hundred (12,500.00) dollars by the said Dent Limited conveyance to the said Dent Limited be executed under the seal of the Corporation by the Commissioner and the Clerk and delivered to the said Dent Limited.

3. This By-law may be cited as "DENT LIMITED LAND SALE BY-LAW 1935."
