

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1509.



A BY-LAW to authorize the execution of an agreement between J. A. McIver, M.D. and C. M. Eaton, M.D. acting for and on behalf of Medical Practitioners practicing in the Municipality of Burnaby and the Corporation of the District of Burnaby.

THE COMMISSIONER for the Corporation of the District of Burnaby ENACTS as follows:

1. Authority is hereby given to the Commissioner and Clerk of the Corporation of the District of Burnaby to sign, execute, and affix the Corporate seal to and give delivery to J. A. McIver, M.D. and C. M. Eaton, M.D. therein named of an agreement between the said J. A. McIver, M.D. and C.M. Eaton, M.D. acting for and on behalf of Medical Practitioners practicing in the Municipality of Burnaby, and the Corporation of the District of Burnaby, providing for Medical Treatment to persons in receipt of relief within the Municipality of Burnaby on the terms and conditions set forth in said agreement, a copy of which is hereunto annexed and that all as an Act and Deed of the said The Corporation of the District of Burnaby.

2. This By-law shall take effect on the registration thereof as provided in Section 178 of the "Municipal Act".

3. This By-law may be cited as "BURNABY MEDICAL AID AGREEMENT AUTHORIZATION BY-LAW 1935."

THIS AGREEMENT made the First (1st) day of May, in the year of our Lord, one thousand nine hundred and thirty four.

BETWEEN:

J A. McIver (Physician) of 4103 East Hastings St. and Carl M. Eaton (Physician) of 4001 East Hastings Street, both in the Municipality of Burnaby acting in and on behalf of the Medical Practitioners practising in the Municipality of Burnaby

Hereinafter called the "Physicians"  
OF THE FIRST PART.

AND

THE CORPORATION OF THE DISTRICT OF BURNABY  
Hereinafter called the "Corporation"  
OF THE SECOND PART.

WITNESSETH:-

That the said Physicians in consideration of the covenants, promises and agreements on the part of the Corporation hereinafter contained, hereby covenant, promise and agree to and with the Corporation that they the said Physicians will render professional services covering ordinary cases of medicine and minor surgery, including supply of necessary drugs, medicines, dressings, etc. (exclusive of Insulin) to active relief recipients in the Municipality of Burnaby.

That the Corporation hereby covenants, promises and agrees to and with the said Physicians to pay for the said service the sum of Eight hundred and Fifty (\$850.00) dollars per month, exclusive of the fees for maternity cases as hereinafter provided.

That the Physicians further undertake and agree to provide obstetrical and maternity treatment to relief recipients requiring same in their own homes, if not prejudicial to their safety at a flat rate of Twenty (\$20.00) Dollars.

In the supplying of drugs, medicines, dressings etc. it is hereby agreed between the parties hereto, that the accounts submitted by Druggists, after check and approval, by the Secretary of the Burnaby Doctors Association, will be paid for by the Corporation from the said sum of \$850.00, the balance of the said sum shall be paid over to the Physicians, together with a statement showing the amounts paid to each Druggist segregated showing the cost of prescriptions filled on the order of each individual Physician, not later than the fifteenth day of the month following the month in which the treatment and Drugs are supplied.

This Agreement shall remain in force for a period of three months to be computed from the First day of May 1935, provided that at the expiration of the said term no other arrangement is agreed upon, then this agreement will continue in full force and effect until terminated by either party hereto upon giving one months notice in writing to the other party to that effect.

Notice as hereinbefore recited shall be deemed to have been properly made and given by the transmission of such notice by registered mail addressed to the Secretary of the Burnaby Doctors Association, Dr. C. M. Eaton, 4001 Hastings St. E. Vancouver, B. C. on behalf of the Physicians and the Municipal Clerk, Municipal Hall, Burnaby via New Westminster, B.C. on behalf of the Corporation.

It is further understood and agreed that the services to ~~be~~ be rendered by the Physicians shall be in accordance with the recognized ethics of ordinary private practice, and it is further understood and agreed that in the event of any dispute arising between the parties hereto in respect of any matter or thing arising from the performance of this agreement, the whole matter shall be referred to the Medical Health Officer of the Corporation whose decision shall be binding upon all parties hereto.
