BORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1511.

A BY-LAW to authorize the sale of certain Tax Sale Lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor other lands in the Municipality.

WHEREAS the Corporation has acquired under Tax Sale proceedings the lands described in the first column of Schedule "A" hereto annexed.

AND WHEREAS the persons named in the second column of the said Schedule "A" are the owners of the lands set opposite their respective names in the third column of the said Schedule "A"

AND WHEREAS the said persons respectively have requested the Corporation to convey to them the said lands described in the first column of the said Schedule "A" and to accept in full or part payment therefor the lands described in the third column of the said Schedule "A".

AND WHEREAS the Commissioner deems it expedient to effect such exchange of lands:

THE COMMISSIONER of the Corporation of the District of Burnaby enacts as follows:-

1. Upon the execution and delivery to the Corporation by the said persons respectively named in the second column of the said Schedule "A" hereunto annexed and hereby incorporated with this By-law, of a good and sufficient Deed in Fee Simple of the lands set opposite their respective names in the third column of the said Schedule "A" together with such other consideration as may be therein expressed, free and clear of all encumbrance whatsoever, the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a conveyance of the said lands respectively set forth in the first column of the said Schedule "A" hereto annexed and incorporated with this By-law to the purchaser named intthe second column of the said Schedule "A" and to deliver such **vonveyance** when so executed to the purchaser.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 2, 1935."
