BY-LAW NO. 1520.

A BY-LAW to amend the "Burnaby Trades License By-law 1927"

The Commissioner for the Corporation of the District of Burnaby ENACTS as follows:

1. Schedule "A" of "Burnaby Trades License By-law 1927 as amended by Section 1 of "Burnaby Trades License By-law 1927 Amendment By-law No. 2, 1928" is hereby further amended by adding to paragraph 34 the following: "Provided that the license fee for each truck owned and operated by the holder of a subsisting trades license, except a license taken out under the provisions of paragraph 63 hereof, shall be the sum of \$2.50 for every six months.

2. Said Schedule "A" is hereby further amended by adding thereto as paragraph 68 the following:

68. From any person who goes from place to place or house to house taking orders for or selling or offering for sale or who takes orders for or sells or offers for sale or vends on any street, lane, or public place in the municipality, any kind of fuel, whether in full loads or parts of a load and whether such person is so acting on his own behalf or is a servant or employee of another, a sum not exceeding \$10.00 for every six months.

3. This By-law may be cited as Burnaby Trades License By-law 1927, Amendment By-law 1935.

Schedule to Burnaby Trades License By-law
consolidated up to July 11th. 1934.

SCHEDULE "A"

1. From any person keeping a hotel or building where a billiard or pool table is used for hire or profit \$5.00 for each table for every six months.
2. From any person keeping a bowling alley or rifle gallery for hire or profit, \$5.00 for every six months.
3. From any person carrying on the business of a wholesale merchant or trader, \$10.00 for every six months.
4. From every person carrying on the business of a retail merchant or trader, \$2.50 for every six months.
5. Any person paying a license under Clauses 3 or 4 hereof shall be entitled to change his place of business at pleasure but not to carry on business at two places at the same time under one license.
6. From any hawker, peddler, or huckster, \$10.00 for every six months.
7. From any person who, either on his own behalf or as agent for another, sells, or solicits or takes orders for the sale, by retail, of goods, wares, or merchandise to be supplied by any person not doing business in the said Municipality, \$10.00 for every six months.
8. From any person keeping or carrying on a public laundry \$5.00 for every six months.
9. From any person who either on his own behalf or as agent for another or others solicits or takes orders for laundry work to be done by a public laundry situate outside the limits of the Municipality, \$10.00 for every six months.
10. From any person carrying on the business of a pawnbroker \$25.00 for every six months.
11. From any person carrying on the business of a second-hand dealer other than a dealer in second-hand cars or junk-

dealer, \$10.00 for every six months.

12. From any person owing or keeping cabs, carriages, carts, drays, trucks, motor-cars, automobiles, or other conveyances or vehicle for hire (whether with or without a driver) \$5.00 for every six months.

13. Repealed July 1934.

14. From any person keeping a livery-stable, \$10.00 for every six months.

15. From any person carrying on the business of a dealer in second-hand or used automobiles or motor-cars, \$10.00 for every six months.

16. From any person carrying on the business of a dealer in new automobiles or motor-cars or a dealer in both new and second-hand automobiles or motor-cars, \$20.00 for every six months; the holder of any license under this or the paragraph next preceding shall also be entitled to carry on the business of selling automobile accessories, gasoline, oil, and supplies, and of repairing automobiles or motor-cars without taking out any further license therefor.

17. From every bank, at one place of business \$50.00 for every six months and for each other place of business \$20.00 for every six months.

18. From any person carrying on the business of manufacturing beverages for human consumption or of selling the same wholesale \$5.00 for every six months, in addition to the license fee for a wholesale merchant or trader.

19. From every person carrying on the business of a shipbuilder or shipyard, \$10.00 for every six months.

20. From any person selling property by auction (not being a Crown offer selling Crown property by auction, or a Sheriff, Sheriff's Officer, or bailiff selling lands, goods, or chattels, under a judgment or in satisfaction of rent or taxes) \$5.00 for every six months.

21. From any transient trader doing business within the limits of the Municipality, \$100.00 for every six months or part thereof, in addition to the fee ~~tax~~ for any other license under this section.

22. From any transient real-estate agent or land agent, \$25.00

for every six months.

23. From any person who exhibits a public circus, menagerie, hippodrome, horse-show, dog or pony show, \$100.00 for each day of such exhibition.

24. From the proprietor, lessee or manager of any theatre, concert hall or other place of amusement, entertainment, or exhibition, according to the seating capacity of such theatre, concert hall, or other place of amusement, entertainment, or exhibition, allowing 22 inches for each seat the following amounts:

1. For every place seating 975 persons or more \$100.00 for 1 year; \$35.00 for 3 months; \$15.00 for 1 month, \$2.50 for one day.

2. For every place seating 400 persons and less than 975, \$50.00 for 1 year; \$20.00 for three months; \$10.00 for one month, \$2.00 for one day.

3. For every place seating less than 400 persons \$25.00 for 1 year; \$15.00 for three months; \$7.50 for one month; \$1.00 for one day; Provided that all licenses issued under the provisions of this clause shall be known and designated as "Theatre Licenses" but no license shall be required in respect of any exhibition concert, or ~~the~~ other entertainment for the benefit of any church, school, or hospital, or any charitable entertainment by any ~~an~~ amateur dramatic or musical association or literary society.

25. From any person or corporation carrying on the business of an express company, \$5.00 for every six months.

26. From any telephone company, electric light company, gas company, street railway or tramway company, power company or waterworks company, \$50.00 for every six months. In the event of one company carrying on business of more than one of the kinds or descriptions hereinbefore in this paragraph enumerated, it shall be liable to hold and pay for a license in respect of each kind or description of business so carried on.

27. From any person carrying on the business of a trust Company investment, loan or mortgage agency, society, or company, \$10.00 for every six months.

28. From any person carrying on the business of a fur-trader, \$20.00 for every six months.

29. From any person exhibiting for gain or profit waxworks, circus riding, rope-walking, dancing, tumbling, wrestling, or other acrobatic or gymnastic performance, wild animals, trained, animals, natural or artificial curiosities, legerdemain, jugglery, or other like tricks, glass-blowing, tableaux or other performance, collection, or exhibition, when the same is exhibited elsewhere than in a theatre or other place duly licensed under paragraph 24 of this Schedule \$20.00 for every six months or \$5.00 for each day of such exhibition.

30. From any person who carries on the business of stevedore or who takes contracts to load or unload ships, \$25.00 for every six months.

31. From any person carrying on the business of a plumber, domestic, heating or sanitary engineer, building contractor, or electrical contractor, \$2.50 for every six months.

32. From any person carrying on the business of a gasoline service station, \$5.00 for every six months. Provided, however, that this clause shall not apply to any person who operates a garage and pays a license therefor.

33. Repealed.

34. From the owner or driver of every truck plying for hire or used for the delivery of wood, coal, merchandise, or other commodity, \$5.00 for every six months for each truck.

35. From the owner of every truck used for the delivery of gasoline and oils to service stations, with weight when loaded exceeding five tons, \$10.00 for every six months, with an additional charge of \$2.00 for each ton exceeding five tons.

36. From any person carrying on the business of manufacturing boxes or the business of manufacturing sash and doors and woodworking, \$5.00 for every six months.

37. From every person carrying on the business of interior decorating or sign painting \$2.50 for every six months.
38. From every person carrying on the business of a painter, (other than a sign painter) or plasterer \$2.50 for every six months.
39. From every dealer in explosives \$20.00 for every six months.
40. ~~From~~ Repealed.
41. From every milk vendor \$5.00 for every six months.
42. From every person carrying on the business of mimeographing or printing, \$5.00 for every six months.
43. From every person carrying on the business of an undertaker ^{10.00} \$5.00 for every six months.
44. From every person carrying on the business of an upholsterer \$2.50 for every six months.
45. From every person carrying on the business of a vulcanizing shop, ^{5.00} \$2.50 for every six months.
46. From every person carrying on the business of manufacturing fertilizers, \$20.00 for every six months.
47. From every engineer and land surveyor \$5.00 for every six months.
48. From every optometrist or refractionist \$5.00 for every six months.
49. From every dental surgeon, osteopath or chiropractor, \$5.00 for every six months.
50. From every faith healer or mental healer ^{20.00} \$25.00 for every six months.
51. From each person practising as a barrister or solicitor \$5.00 for every six months.
52. From every ^{person} practising as a conveyancer \$5.00 for every six months.
53. From every person practising as a physician or surgeon \$5.00 for every six months.
54. From every person practising as a veterinary surgeon \$5.00 for every six months.

55. From every person carrying on the business of a druggist
\$2.50 for every six months.

56. From every person carrying on the business of scavenger
or chimney sweep, \$1.00 for every six months.

57. From any person following within the Municipality any
trade, occupation or calling not hereinbefore enumerated, or
who enters into any contract or agreement to perform any work
or furnish any material \$5.00 for every six months, Provided
always that no person employed as a journeyman or for wages
only and not employing other persons shall be subject to the
provisions of this section.

58. From any person dealing in lumber or operating a
lumber yard, \$5.00 for every six months.

59. From any person operating a cafe or restaurant, \$2.50
for every six months.

60. Barber, handmen milliner dressmaking optician photographer and
60a. From every person letting individual rooms, suites,
or rooms or lodgings for hire, either in a hotel, rooming house,
apartment house, lodging house, or elsewhere, and whether or
not board or meals are supplied to the occupants thereof, Fifty
(50¢) cents for every six months for each room let or available
for letting. Provided, however, that persons having not more
than two rooms available for letting shall not be required to
take out or hold a license under this paragraph.

61. From every person carrying on the business of a saw
mill, shingle mill, pole and tie mill - Twenty (\$20.00) dollars
for every six months.

62. From every person carrying on the business of steel
manufacturing or fabricating - Twenty (\$20.00) dollars for every
six months.

63. From every person carrying on the business of an oil
refinery - Twenty (\$20.00) dollars for every six months.

~~64. From every person carrying on the business of a Junk
dealer, Ten (\$10.00) dollars for every six months.~~

~~65. From every person who carries on the business of a garage
for repair or storage of automobiles and trucks, Ten (\$10.00)
dollars for every six months.~~

66. From the owner of every truck used for the collection of produce, wood, merchandise, or other commodities from premises within the Municipality not in the occupation of such owner or driver for sale outside of the Municipality - Five (\$5.00) dollars for every six months for each truck.

67. From every person carrying on the business of an Automobile or Tourist Camp - \$15.00 for every six months.

Paragraph 24, Schedule "A"
"BURNABY TRADES LICENSE BY-LAW 1927,
AMENDMENT BY-LAW NO. 2. 1928.

24. From the proprietor, lessee or manager of any theatre, concert hall or other place of amusement, entertainment, or exhibition, according to the seating capacity of such theatre, concert hall, or other place of amusement, entertainment, or exhibition, allowing 22 inches for each seat the following amounts:

1. For every place seating 975 persons or more \$100.00 for 1 year; \$35.00 for 3 months; \$15.00 for 1 month; \$2.50 for one day.

2. For every place seating 400 persons and less than 975, \$50.00 for 1 year; \$20.00 for three months; \$10.00 for one month; \$2.00 for one day.

3. For every place seating less than 400 persons \$25.00 for 1 year ; \$15.00 for three months; \$7.50 for one month; \$1.00 for one day;

Provided that all licenses issued under the provisions of this clause shall be known and designated as "Theatre Licenses" but no license shall be required in respect of any exhibition concert, or other entertainment for the benefit of any church, school, or hospital, or any charitable entertainment by any amateur dramatic or musical association or literary society.
