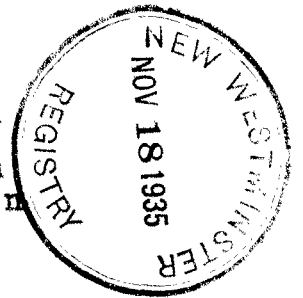


CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1533

A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor, other lands in the Municipality.



WHEREAS the Corporation has acquired under Tax Sale proceedings lands described as Lot 6 of Blocks 17 and 18, District Lot 34, Group 1, New Westminster District, Map No. 1355.

AND WHEREAS Cecil M. Wardell, of 4310 Inman Avenue in the Municipality of Burnaby is the owner in fee simple of lands described as Lot 8, Block 19, D.L. 208. Group 1. New Westminister District, Map No. 2501.

AND WHEREAS Alice Maud Wardell, of 4310 Inman Avenue in the Municipality of Burnaby, is the owner in fee simple of lands described as Lots 9 and 12, of Block 19, District Lot 208, Group 1, New Westminister District, Map No. 2501.

AND WHEREAS the said Cecil M. Wardell, and the said Alice Maud Wardell have requested the Corporation to convey to the said Alice Maud Wardell, the lands owned by the Corporation, viz: Lot 6, Blocks 17 and 18, D.L. 34. Group 1, New Westminister District, Map No. 1355, and to accept in payment therefor the lands presently owned by the said Cecil M. Wardell, and Alice Maud Wardell, together with the sum of Ten (\$10.00) dollars.

AND WHEREAS the Commissioner for the Corporation of the District of Burnaby deems it expedient to effect such exchange of lands:

THE COMMISSIONER for the Corporation of the District of Burnaby therefore ENACTS as follows:

1. Upon the execution and delivery to the Corporation by the said Cecil M. Wardell and Alice Maud Wardell of a good and sufficient deed in Fee simple of the said lands described as Lot 8, Block 19, D.L. 208 and Lots 9 and 12, Block 19, D.L. 208, respectively, together with the sum of

Ten (\$10.00) dollars, free and clear of all encumbrance whatsoever, the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a conveyance of Lot 6, Blocks 17 and 18, D.L. 34, Group 1. New Westminster District, Map No. 1355, to the said Alice Maud Wardell, and to deliver such conveyance when so executed to the said Alice Maud Wardell.

2. This By-law may be cited as "Burnaby Property Exchange By-law No. 4, 1935."
