CORPORATION OF THE DISTRICT OF BURNABY

## BY-LAW NO. 1537.

A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor, other lands in the Municipality.

WHEREAS the Corporation has acquired under Tax Sale proceedings lands described as Lot Three (3) of Block Three (3) subdivision of District Lot One hundred and fifty eight (158) Group One (1) New Westminster District, Map No. 2044.

AND WHEREAS Lucy Smith, Married woman, Sherman, P.O. Municipality of West Vancouver, and Elizabeth Ogden Green, wife of Jack Green, Merchant, of 3448 Patrick Street, in the Municipality of Burnaby, are the registered owner and the holder of a registered right to purchase respectively of Lot One (1) Block Three (3) District Lot One hundred and fifty eight (158) Group One (1) New Westminster District, Map No. 2044:

AND WHEREAS the said Lucy Smith and Elizabeth Ogden Green have requested the Corporation of the District of Burnaby to convey to the said Elizabeth Ogden Green, the lands owned by the Corporation, viz: Lot 3, Block 3, D.L. 158, Group 1, New Westminster District, Map No. 2044, and to accept in full payment therefor, the lands presently owned by the said Lucy Smith and Elizabeth Ogden Green:

AND WHEREAS the Commissionerfor the Corporation of the District of Burnaby deems it expedient to effect such exchange of lands:

THE COMMISSIONER for the Corporation of the District of Burnaby therefore ENACTS as follows:

1. Upon the execution and delivery to the Corporation by the said Lucy Smith and Elizabeth Ogden Green of a good and sufficient deed in fee simple of the said lands described as Lot 1, Block 3, District Lot 158, Broup 1. New Westminster

District, Map No. 2044, free and clear of all encumbrance whatsoever, the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a conveyance of Lot Three (3) of Block Three (3) of District Lot One hundred and fifty eight (158) Group One (1) New Westminster District, Map No. 2044, to Elizabeth Ogden Green, and to deliver such vonveyance when so executed to the said Elizabeth Ogden Green.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 5. 1935."
