

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1557.

A BY-LAW to authorize the sale of certain Tax Sale Lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor, other lands in the Municipality.

WHEREAS the Corporation has acquired under Tax Sale proceedings lands described as Lot seven (7), Block twelve (12), of District Lot Sixty-nine (69), Group One (1), Map numbered 1321.

AND WHEREAS Robert S. Gould of 3954 - 12th. Avenue in the Municipality of Burnaby, is the owner in fee simple of Lots One (1), Two (2), and Three (3), of Block Twenty-eight (28), District Lot One hundred and twenty-two (122), Group One (1), Map numbered 1308.

AND WHEREAS the said Robert S. Gould has requested the Corporation of the District of Burnaby to convey to Robert S. Gould the lands owned by the Corporation, viz: Lot seven (7), Block twelve (12), of District Lot Sixty-nine (69), Group One (1), Map numbered 1321, and to accept in full payment thereof a conveyance of the said lands owned by him, together with the sum of Ten (\$10.00) Dollars.

AND WHEREAS the Commissioner deems it expedient to effect such exchange of lands.

THEREFORE the Commissioner for the Corporation of the District of Burnaby enacts as follows:-

1. That upon the execution and delivery to the Corporation by the said Robert S. Gould of a good and sufficient deed in fee simple of said Lots One (1), Two (2) and Three (3), Block Twenty-eight (28), District Lot One hundred twenty-two (122) Group One, Map Numbered 1308 free and clear of all encumbrances whatsoever the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a

conveyance of ALL AND SINGULAR, that certain parcel or tract of land and premises situate, lying and being in the Municipality of Burnaby, in the District of New Westminster, and the Province of British Columbia, and being composed of Lot Seven (7), of Block Twelve (12), of District Lot Sixty-nine (69), Group One (1) Map Numbered 1321, deposited, to the said Robert S. Gould.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 1. 1936."
