CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1568.

A BY-LAW to acquire landw within the Municipelity of Burnaby.

WHEREAS under the provisions of Sub-section 30 of Section 54 of the "Municipal Act" the Municipal Council is authorized to make and pass By-laws to acquire lands:

AND WHEREAS it is desirable and expedient that the road allowance of Nelson Avenue adjacent to Block 51, District Lot 157 be widened. AND WHEREAS Isabella Morrison and James Morrison, of 1210 Nelson Avenue have agreed to Convey to the Corporation for the purpose aforesaid the Easterly Twenty feet of said Block 51. WHEREAS IT is deemed expedient to accept the said offer.

THEREFORE the Commissioner of the Corporation of the District of Burnaby emacts as follows:-

1. The Easterly Twenty (20) feet of Block Fifty one (51) subdivision of District Lot One hundred and fifty seven (157) Group One (1) according to Map No. 612 Deposited, New Westminster District, in the Province of British Columbia, shall be acquired from Isabella Morrison and James Morrison, both of 1210 Nelson Avenue, in the Municipality of Burnaby, and Province of British Columbia, for Corporate purposes

2. On execution and delivery of Conveyance by said Isabella Morrison and James Morrison of 1210 Nelson Avenue in the Municipality of Burnaby, and Province of British Columbia, to the Corporation of the District of Burnaby, they shall be paid the sum of One (\$1.00) Dollar.

This By-law shall take effect upon its being finally passed.

4. This By-law may be cited as "NELSON AVENUE LAND ACQUISITION BY-LAW 1936."


