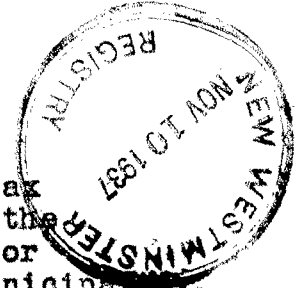


CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1611



A BY-LAW to authorize the sale of certain Tax Sale Lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor other lands in the Municipality.

WHEREAS the Corporation has acquired under Tax Sale proceedings lands and premises described as Lot Four (4) of Block Thirty (30) Subdivision of District Lot One hundred and fifty one (151) One Hundred and fifty two (152) and One hundred and fifty three (153), Group One (1), Map No. 1520.

AND WHEREAS Gwendolen Gladys Andrew is the owner of lands and premises described as Lot Thirteen (13), Block Sixteen (16) of District Lot Twenty eight Central (28.C) Group One (1), Map No. 627.

AND WHEREAS the said Gwendolen Gladys Andrew has requested the Corporation to convey to Frank Gill of 57 - 17th Avenue West, in the City of Vancouver and Gwendolen Gladys Andrew of 327 - 17th Avenue in the Municipality of Burnaby, all in the Province of British Columbia the lands and premises described as Lot Four (4) Block Thirty (30) of Subdivision of District Lot One hundred and fifty one (151) One hundred and fifty two (152) and One hundred and fifty three (153), Group One (1), Map No. 1520 and to accept in full payment, therefor Conveyance of said Lot Thirteen (13) Block Sixteen (16) of District Lot Twenty eight Central (28.C) together with sum of Forty five (\$45.00) dollars of lawful Money of Canada

AND WHEREAS the Commissioner deems it expedient to effect such exchange of lands:

THE COMMISSIONER of the Corporation of the District of Burnaby ENACTS as follows:-

1. Upon the execution and delivery to the Corporation by the said Gwendolen Gladys Andrew, of a good and sufficient

Deed in Fee Simple of the lands and premises described as Lot Thirteen (13) of Block Sixteen (16) of District Lot Twenty eight Central (28.0) Group One (1) Map No. 627 together with the sum of Forty five (\$45.00) dollars of lawful Money of Canada, free and clear of all encumbrance whatsoever, the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and corporate seal of the Corporation of the District of Burnaby to a conveyance of the said lands described as Lot Four (4) of Block Thirty (30) of Subdivision of District Lot One hundred and fifty one (151) One hundred and fifty two (152) and One hundred and fifty three (153) Group One (1), Map No. 1520, to Frank Gill of 57 - 17th Avenue West, in the City of Vancouver and Gwendolen Gladys Andrew of 327 - 17th Avenue in the Municipality of Burnaby, all in the Province of British Columbia and to deliver such Conveyance when so executed to the said Frank Gill and Gwendolen Gladys Andrew.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 3. 1937."
