A BY_LAW to authorize the Commissioner for the Corporation of the District of Burnaby to accept the sum of One thousand, six hundred and ninety seven dollars and fifty nine cents (\$1,697.59) in full payment of taxes due on Lots numbered One (1) and Two (2) of Block One (1) of District Lot Seventy nine South (79.S.) up to the 31st day of December, 1935.

WHEREAS Mrs. Mary Mathers, Widow, of the City of Vancouver, Province of British Columbia, is the owner in fee of lands and premises described as Lots One (1) and **Two** (2) of Block One (1) of subdivision of South part of District Lot Seventy nine (79.S.) Group One (1) New Westminster District, Map No. 1995.

AND WHEREAS the said lands were sold by the Collector for the Corporation of Burnaby for delinquent taxes on the 9th day of December, 1935, the Corporation of the District of Burnaby being declared the purchaser.

AND WHEREAS the amount necessary to redeem the said lands now amounts to \$2,197.04

AND WHEREAS the said Mrs.Mary Mathers has represented to the Commissioner that the said lands were over assessed in the years 1933 and 1934.

AND WHEREAS the said Mrs.Mary Mathers has offered the sum of \$1,697.59 in full settlement of redemption up to December 31st. 1935.

AND WHEREAS the Commissioner for the Corporation of the District of Burnaby deems it expedient to accept the said offer.

THEREFORE the Commissioner for the Corporation of the District of Burnaby ENACTS as follows:

1. That the Collector for the Corporation of the District of Burnaby be and is hereby authorized to accept from Mrs. Mary Mathers, the sum of One thousand, six hundred and ninety seven dollars and fifty nine cents (\$1,697.59)

in full settlement of all delinquent taxes owing by her up to the Thirty first (31st) day of December, 1935 upon the lands and premises described as Lots One (1) and Two (2) of Block One (1) of subdivision of South part of District Lot Seventy nine (79.S.) Group One (1) New Westminster District, Map No. 1995, in the Municipality of Burnaby, and to grant and deliver to the said Mary Mathers a certificate that the said lands and premises have been redeemed as provided in Section 282 (1) of the "Municipal Act".

This By-law may be cited as "Mathers Tax Adjustment 2. By-law 1937"
