

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1646

A BY-LAW to define and set aside certain lands within the Municipality of Burnaby for Park purposes.

WHEREAS by paragraph "d" of sub-section 179 of Section 59 of the "Municipal Act", R. S. B. C. 1936 provided that in every Municipality the Council may, by By-law finally passed by a three-fourths vote of all the members thereof, and without obtaining the assent of the electors, define an area comprising lands that have become the property of the Municipality through tax sale proceedings and set aside such area for park purposes, for recreation grounds, or school sites, or other public purposes.

AND WHEREAS it is considered expedient and in the public interest that the hereinafter mentioned lands in the Municipality of Burnaby should be so set aside.

THEREFORE the Commissioner in exercise of all the powers him thereunto enabling ENACTS as follows:-

1. There is hereby defined and set apart for park purposes all of the undermentioned lands:

- (a) Lot "B" of Block numbered Twenty seven (27) of District Lot numbered One hundred and fifty two (152), Group One (1), New Westminster District, Map No. 5847.
- (b) Lots numbered One (1) to Eight (8) inclusive of Subdivision of Lot numbered Three (3) of Blocks numbered Two (2) and Three (3) of District Lot numbered Twenty five East (25E) Group One (1), New Westminster District, Map No. 1465.
- (c) Lot numbered Thirteen (13) of Block numbered Two (2) of District Lot numbered Thirty (30) Group One (1), New Westminster District, Map No. 3036. Lots numbered One (1) to Seven (7) inclusive and Sixteen (16) to Twenty (20) inclusive of Block numbered Three (3) of District Lot numbered Thirty (30), Group One (1), New Westminster District, Map No. 3036 and

Lots numbered One (1) to Seven (7) of Block numbered Four (4) of District Lot numbered Thirty (30), Group One (1), New Westminster District, Map No. 3036.

2. This By-law may be cited as "BURNABY PARK DEDICATION BY-LAW 1938."
