BY-LAW 1676.

A BY-LAW to authorize the sale of certain Tax Sale
Lands belonging to the Corporation of the
District of Burnaby, and to accept in part
or full payment therefor other lands in the
Municipality.

WHEREAS the Corporation has acquired under Tax Sale proceedings, lands and premises described as (a) Block One hundred (100) District Lor One hundred and thirty two (132) Group One (1) Map No. 1493, and Lot Thirty six (36) of Block Three (3) of District Lot Ninety south (908) Group One (1) Map No.555, all in the District of New Westminster.

AND WHEREAS Ralph Lerne Abbott of 2929 Sixth Avenue
West in the City of Vancouver, Province of British Columbia has
offered to purchase the land and premises described as Block One
hundred, D. L. 132. Group 1. Map No. 1493, and has offered in
full payment therefor conveyance of Lot 11, Block 40. D.L.122/3/4,
Group 1. Map No. 1543, New Westminster District free and clear of
all encumbrance plus the sum of One hundred and twenty five
dollars.

AND WHEREAS Margaret S. AND WHEREAS the Commissioner for the Corporation of the District of Burnaby deems it expedient to accept the said offers respectively.

THE COMMISSIONER for the Corporation of the District of Burnaby therefore ENACTS as follows:

1. Upon the execution and delivery to the Corporation of a good and sufficient Deed of the Lands and premises described as

D.L. 122/3/4 from Ralph Lorne Abbott free and clear of all encumbrance whatsower, together with the sum of One hundred twenty five dollars, the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and Corporate seal of the Corporation of the District of Butnaby to a Conveyance of Lands and premises described as Block One hundred (100) D.L. 132 to R. L. Abbott and to deliver such conveyance to the said Ralph Lorne Abbott.

- 2. Upon the execution and delivery to the Corporation of a good and sufficient deed of the lands and premises described as Lots 33 and 34, S.D. "A" Block 4. D.L. 91.S.W. Group 1. N.W.D. Map No. 1346 from Edward E. McIntyre free and clear of all encumbrance whatsoever, the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and Corporate seal of the Corporation to a conveyance of lands and premises described as Lot 36. Block 3. D.L. 90.S. to Margaret S. McIntyre, wife of said Edward E. McIntyre.
- 3. This BY-LAW may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 4, 1939."
