

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1700.

A BY-LAW to amend Burnaby Land Sale By-law
No. 3, 1940.

WHEREAS the Commissioner for the Corporation of the District of Burnaby did by By-law No. 1698 entitled "Burnaby Land Sale By-law No. 3, 1940", Schedule "I", authorize the sale of Lot 5, S.D. 10, Block 3, D.L. 206, Group 1, N. W. D., Map No. 1323 to Evelyn E. McIntyre of 523 Sperling Avenue, Burnaby, for the sum of \$125.00.

AND WHEREAS the said Evelyn E. McIntyre has represented to the Commissioner that she is unable to complete the purchase.

AND WHEREAS the Commissioner deems it advisable that the said sale to the said Evelyn E. McIntyre be cancelled.

THEREFORE the Commissioner for the Corporation of the District of Burnaby ENACTS AS FOLLOWS:-

1. By-law No. 1698 of the Corporation of the District of Burnaby, entitled Burnaby Land Sale By-law No. 3, 1940, Schedule "I" is hereby amended by striking out the following item: "Lot 5, S.D. 10, Block 3, D.L. 206, Map No. 1323, Evelyn E. McIntyre, 523 Sperling Avenue, Burnaby, \$125.00"

2. This By-law may be cited as "Burnaby Land Sale By-law No. 3, 1940, Amendment By-law 1940."
