## BY-LAW NO. 1702.

A BY-LAW to authorise the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor other lands in the Municipality.

whereas the Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as Lot Eighteen (18) of Block Seventeen (17) District Lot Ninety nine (99), Group One (1), New Westminster District, Map No. 4452.

AND WHEREAS John A. Calder and Mary E. Calder, both of 3993 Dumfries Street in the City of Vancouver are the owners of lands and premises described as Lot Eight (8), Block Five East half (5E%), District Lot Ninety nine (99), Group One (1), New Westminster District, Map No. 1623.

have requested the Corporation to convey to them the said lands described as Lot Eighteen (18) of Block Seventeen (17) District Lot Ninety nine (99), Group One (1), New Westminster District, Man No. 4452, and to accept in full payment therefor conveyance of the lands and premises described as Lot Eight (8), Block Five East half (5E), District Lot Ninety nine (99), Group One (1), New Westminster District, Map No. 1623.

AND WHEREAS the Commissioner for the Corporation of the District of Burnaby deems it expedient to effect such exchange of lands.

THE COMMISSIONER for the Corporation of the District of Burnaby therefore ENACTS as follows:

1. Upon the execution and delivery to the Corporation of the District of Burnaby by John A. Calder and Mary E. Calder of a good and sufficient deed of the lands and premises described

as Lot Eight (8) of Block Five, East half (5E2) of District
Lot Minety nine (99), Group One (1), New Westminster District
Map No. 1623, free and clear of all encumbrance whatsoever,
the Commissioner and Clerk of the Corporation are hereby
suthorized and empowered to execute and set the official and
Corporate Seal of the Corporation of the District of Burnaby
to a Conveyance of lands and premises described as Lot Eighteen
(18) of Block Seventeen (17), District Lot Ninety nine (99),
Group One (1), New Westminster District, Map No. 4452 to the
said John A. Calder and Mary E. Calder, and to deliver such
conveyance when so executed to the said John A. Calder and
Mary E. Calder.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 2, 1940."
