A BY-LAW to authorize the sale of Lots 2 and 3, Block 28, D.L. 172, Group 1, New Westminster District, Map No. 2974 by the Corporation of the District of Burnaby.

WHEREAS the Corporation of the District of Burnaby acquired Lots 2 and 3, Block 28, D.L. 172, Group One (1), Map No. 2974 for Corporation purposes in October, 1926.

AND WHEREAS the said land is no longer required for Corporate purposes,

AND WHEREAS Robert Adam Wilson and Norah Wilson, both of 1920 Edinburgh Street in the City of New Westminster have offered the sum of One hundred and fifty (\$150.00) dollars for Lot 2, Block 28, D.L. 172, Group One (1), New Westminster District, Map No. 2974.

AND WHEREAS Doris Longstaff of 1816 Edinburgh Street, in the City of New Westminster has offered the sum of One hundred and fifty (\$150.00) dollars for Lot 3, Block 28, D.L. 172, Group One (1), New Westminster District, Map No. 2974.

AND WHEREAS the Commissioner for the Corporation of the District of Burnaby deems it advisable to accept the said offers.

THEREFORE the Commissioner for the Corporation of the District of Burnaby ENACTS as follows:-

1. That Lot 2, Block 28, D.L. 172, Group One (1), New Westminster District, Map No. 2974 be sold and disposed of to Robert Adam Wilson and Norah Wilson, both of 1920 Edinburgh Street in the City of New Westminster for the sum of One hundred and fifty (\$150.00) dollars, and that upon the payment to the Corporation of the said sum of One hundred and fifty dollars, that the Commissioner and Clerk be authorized to execute and set the Corporate Seal to an indenture of Conveyence to the said Robert Adam Wilson and Norah Wilson.

2. That Lot 3, Block 28, D.L. 172, Group (1), New Westminster District, Map No. 2974 be sold and disposed of to Doris Longstaff of 1816 Edinburgh Street in the City of New Westminster for the sum of One hundred and fifty (\$150.00) dollars, and that upon the payment to the Corporation of the said sum of One hundred and fifty dollars, that the Commissioner and Clerk be authorized to execute and set the Corporate Seal to an indenture of Conveyance to the said Doris Longstaff.

3. This By-law shall take effect upon the registration thereof.

4. This By-law may be cited for all purposes as "BURNABY D.L. 172 CORPORATE LAND SALE BY-LAW 1940."
