By-Law No <b>1.713</b>
TO AUTHORIZE THE BORROWING OF CERTAIN MONEYS from The
ROYAL BANK OF CANADA, to meet the current lawful expenditure of the Corporation of the District of Burnaby
for the year 19.40.
Whereas it is necessary and desirable to borrow the sum of Fifty thousand
The Royal Bank of Canada to meet the current lawful expenditure of the Corporation
which becomes payable out of the annual revenue:
And Whereas the said The Royal Bank of Canada has requested the Corporation to
secure the payment of the same as hereinafter set forth:
Acting Commissioner  Be It Therefore Enacted by the Manager Enacted

District of Burnaby as follows:—

2. That the said Corporation be and it is hereby authorized to pay to the said Bank interest on the said sum of **Fifty thousand** (5)50,000.00.

Dollars at the maximum rate of **Four & 2** (43%) per centum per annum, which may be paid or allowed in advance by way of discount, or otherwise howsoever as they may deem best.

3.	That the said sum of filey diousand (250,000,00)	
	Dollars shall be re-payable on or before the 31st	
	day of December , A.D. 1940.	
4.	That the obligation to be given therefor shall be a Promissory Note signed by the next in Commissioner and the Clerk of the Corporation, and shall	
	bear the Corporate Seal of the Corporation, and shall be for a period not exceeding	
	one year, but may be renewed from time to time as circumstances may require.	
5.	There is hereby set aside as security for the payment of such money with all inter-	
	est thereon respectively, the whole of all unpaid taxes assessed and levied in the said	
	District, as shown in the Schedule to this By-Law.
