## CORPORATION OF DISTRICT OF BURNABY

## BY-LAW NO. 1730

A BY-LAW to enable the Corporation of the District of Burnaby to provide for all sums which may be required for the lawful purposes of the Municipality and for School Board purposes, for the year 1941.

- - - - - - -

WHEREAS it is necessary and expedient to pass a By-law for the above named purposes.

THE COMMISSIONER for the Corporation of the District of Burnaby pursuant to the provisions of the 'Municipal Act' and Amending Acts and any other act or acts him thereunto enabling, ENACTS AS FOLLOWS:-

1. There shall be raised, levied and collected for the year 1941 upon the assessed value of all improved taxable land and upon fifty per centum of all taxable improvements in the said Municipality of Burnaby as shown upon the last revised Assessment roll thereof, a tax of Forty nine (49) mills in the dollar for the following purposes:

(a) to provide, in and for the year 1941, in accordance with the provisions of the "District of Burnaby Debt Refunding Act 1940" (1) the sum of \$90,000.00 for payment in the first place of interest on Refunding Debentures Series "A" issued under the said Act and thereafter, so far as the balance will thereunto extend for the purchase or redemption of the said Debentures; (2) the sum of \$10,000.00 to enable the Corporation to make payment of that amount to the Royal Bank of Canada in part satisfaction of the Corporation's indebtedness to the said Bank; (3) a sum sufficient for payment by the Corporation to the said Bank on and in respect of the said indebtedness, of interest at the rate of 41% per annum, payable half yearly on the 2nd day of January and the 2nd day of July, 1941; (4) the sum of \$10,000.00 to enable the Corporation to make payment of that amount to the Province of British Columbia in partial discharge of the Corporation's indebtedness

to the said Province and (5) a sum sufficient for payment by the Corporation to the said Province on and in respect of the said indebtedness, of interest at the rate of  $3\frac{1}{2}$ % per annum, ten and twenty-two one hundredths (10.22) mills in the dollar by way of a special rate to be known as the "MUNICIPAL LOAN RATE".

(b) to provide for the general purposes of the Municipality Sixteen and thirty five (16.35) mills in the dollar to be called the "GENERAL RATE".

(c) to provide for the general purposes of the Board of School Trustees of Burnaby, Seventeen and two-tenths (17.2)mills in the dollar to be called the "SCHOOL RATE".

(d) to provide for a special fund to meet the costs of new school buildings, furnityre and equipment for school buildings, and new school sites, in the Municipal School District of Burnaby, One (1) mill in the dollar to be called the "SCHOOL SPECIAL RATE".

(e) to provide for the payment of the proportion of the estimate for 1941 of the Vancouver and Districts Joint Sewerage and Drainage Board, Four and twenty three one-hundredths (4.23) mills in the dollar to be called the "VANCOUVER AND DISTRICTS JOINT SEWERAGE AND DRAINAGE RATE".

2. There shall be raised and collected for the year 1941 upon the assessed value of all taxable real property in Burnaby Ward 5 District Improvement Area as shown upon the last revised assessment roll thereof, within the boundaries of the area created by By-law No. 565 of the Corporation, a tax of five and five tenths (5.5) mills in the dollar for the following purpose:

(a) to provide for interest only on One hundred and three thousand dollars (\$103,000.00) debentures issued by the said Municipality, Five and five tenths (5.5) mills in the dollar to be called the "BURNABY DISTRICT IMPROVEMENT RATE".

3. There shall be raised, levied and collected for the year 1941 upon the assessed value of the land and upon fifty per centum of improvements in the Burnaby Fire Area No.1. as shewn by the last revised assessment roll thereof a tax of Three and five tenths (3.5) mills in the dollar for the following purpose:

(a) to provide for the housing, maintenance and operation of the fire apparatus provided for the said Fire Area, three and five tenths (3.5) mills in the dollar to be called the "BURNABY FIRE AREA NO.1. MAINTENANCE RATE".

4. There shall be raised, levied and collected for the year 1941 upon the assessed value of the land and upon fifty per centum of improvements in the Burnaby Fire Area No.2. as shewn by the last revised assessment roll thereof a tax of one and two tenths (1.2) mills in the dollar for the following purpose:

(a) to provide for the housing, maintenance and operation of the fire apparatus provided for the said Fire Area, one and two tenths (1.2) mills in the dollar to be called the "FIRE AREA NO.2. MAINTENANCE RATE".

5. There shall be raised, levied and collected for the year 1941 upon the frontage of each lot shewn upon the special assessment roll prepared pursuant to Hastings Street Ornamental Lighting Maintenance By-law 1930 a special rate of Twenty-two (22) cents per front foot to provide for the cost of maintaining ornamental lights installed pursuant to the "District Improvement By-law (Ornamental Lighting) 1929"in that portion of Hastings Street described in the said By-law.

6. There shall be raised, levied and collected for the year 1941 upon the frontage of each lot shown upon the special assessment roll prepared pursuant to Hastings Street Ornamental Lighting Maintenance By-law 1931 a special rate of twenty two (22) cents per front foot to provide for the cost of maintaining ornamental lights installed pursuant to the "District Improvement

By-law (Ornamental Lighting) 1931" in that portion of Hastings Street described in the said By-law.

7. There shall be raised, levied and collected for the year 1941 upon the assessed value of the land and upon fifty per centum of improvements in the Capitol Hill Replotting Area as shown upon the last revised assessment roll thereof, within the boundaries of the District as defined in the preamble to By-law No. 1452 of the Corporation, a tax of seven and fourtenths (7.4) mills in the dollar for the following purpose:

(a) to provide for interest only one Forty three thousand (\$43,000.00) dollars debentures issued by the said Municipality pursuant to "Capitol Hill Replotting Debenture By-law 1933" Seven and four tenths (7.4) mills in the dollar to be called the "CAPITOL HILL REPLOTTING RATE"

8. The said Taxes and special rates shall be payable to the Collector, at the Municipal Hall, Edmonds, of the said Municipality.

9. Provided, however, anything hereinbefore contained to the contrary notwithstanding the sum of One (\$1.00) dollar shall be the minimum taxation upon any parcel of taxable land upon the assessment roll of the Municipality.

10. This By-law may be cited as the "BURNABY REVENUE BY-LAW 1941"
