

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1731.

A BY-LAW to fix the date the Collector shall add percentage additions to the current years taxes unpaid on each parcel of land upon the Collector's Roll for the District of Burnaby.

WHEREAS Section 257 of the "Municipal Act" being Chapter 199 of the Revised Statutes of British Columbia 1936 provides as follows:-

"On the first day of July in each year the Collector shall add to the Current Year's taxes unpaid on each parcel of land and on the improvements thereon, upon the Collector's roll, ten per cent of the amount of the current year's taxes remaining unpaid; and the said taxes unpaid, together with the amount added, shall be deemed to be taxes of the current year due on such land and on the improvements thereon, and the amount added under this section shall when collected form part of the general revenue of the Municipality; provided that the Council may, by By-law passed prior to the transmission of tax notices in any year under Section 253, alter the date on which the percentage shall be added, or may direct that part of such percentage be added on a certain date and part on some other date or dates thereafter, but so that the total percentage of ten per cent shall be added on taxes unpaid on the thirty first day of December of the year in which the taxes are imposed."

AND WHEREAS it is deemed advisable to alter the date upon which the percentage aforesaid shall be added.

THEREFORE, the Commissioner for the Corporation of the District of Burnaby ENACTS as follows:-

1. On the Fifth (5th) day of July, 1941, the Collector shall add to the current year's taxes unpaid on each parcel of land or improvements upon his roll five (5) per centum of the amount thereof, and upon the Fifth (5th) day of August 1941 shall add an additional amount of one (1) per centum thereof; and on the Fifth (5th) day of September 1941 shall add a further additional amount of one (1) per centum thereof; and on the Sixth (6th) day of October, 1941, shall add a further additional amount of one (1) per centum thereof; and on the Fifth (5th) day of November 1941 shall add a further additional amount of one (1) per centum thereof; and on the Fifth (5th) day of December 1941 shall add a further additional amount of one (1) per centum thereof, and the said unpaid taxes together with the amount added as aforesaid shall from the respective dates aforesaid be deemed to be the amount of the current year's taxes due upon the said land and improvements.

2. This By-law may be cited as "BURNABY PERCENTAGE ADDITIONS BY-LAW 1941."
