By-Law No. 1733

TO AUTHORIZE THE BORROWING OF CERTAIN MONEYS from The ROYAL BANK OF CANADA, to meet the current lawful expenditure of the Corporation of the District of Burneby.

Mhereas it is necessary and desirable to borrow the sum of One hundred and seventy five thousand - - - - (\$175,000.00) Dollars from The Royal Bank of Canada to meet the current lawful expenditure of the Corporation which becomes payable out of the annual revenue:

for the year 1941.....

And Whereas the said The Royal Bank of Canada has requested the Corporation to secure the payment of the same as hereinafter set forth:

- 2. That the said Corporation be and it is hereby authorized to pay to the said

  Bank interest on the said sum of **One hundred and seventy five thousand**Dollars at the maximum rate of **Four & 1** per centum per annum,

  which may be paid or allowed in advance by way of discount, or otherwise howso
  ever as they may deem best.

3.	That the said sum of One hundred and seventy five thousand
	Dollars shall be re-payable on or before the 31 st

That the obligation to be given therefor shall be a Promissory Note signed by the Acting Commissioner Maximum and Finance Committee, and the Clerk of the Corporation, and shall bear the Corporate Seal of the Corporation, and shall be for a period not exceeding one year, but may be renewed from time to time as circumstances may require.
