

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1738

A BY-LAW to authorise the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor other lands in the Municipality.

WHEREAS the Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as Lot Three (3) of Block One (1) District Lots One hundred and twenty one (121) and One hundred and eighty seven (187), Group One (1), New Westminster District, Map No. 1354.

AND WHEREAS Catherine Maudsley (Married Woman) of 101 Ronan Avenue in the City of Toronto, North, is the owner of lands and premises described as Lot Two (2) of Subdivision of Lot Four (4) Block "B", District Lot One hundred and eighty eight (188), Group One (1), Map No. 1603, New Westminster District.

AND WHEREAS the said Catherine Maudsley has requested the Corporation to convey to her the said lands described as Lot Three (3) of Block One (1) District Lots One hundred and twenty one (121) and One hundred and eighty seven (187), Group One (1), New Westminster District, Map No. 1354, and to accept in full payment therefor conveyance of the lands and premises described as Lot Two (2) of Subdivision of Lot Four (4), Block "B", District Lot One hundred and eighty eight (188), Group One (1), New Westminster District, Map No. 1603.

AND WHEREAS the Commissioner for the Corporation of the District of Burnaby deems it expedient to effect such exchange of lands.

THE COMMISSIONER for the Corporation of the District of Burnaby therefore ENACTS as follows:

1. Upon the execution and delivery to the Corporation of the District of Burnaby by Catherine Maudsley of a good and

sufficient deed of the lands and premises described as Lot Two (2) of Subdivision of Lot Four (4), Block "B", District Lot One hundred and eighty eight (188), Group One (1), New Westminster District, Map No. 1603, free and clear of all encumbrance whatsoever, the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and Corporate Seal of the Corporation of the District of Burnaby to a Conveyance of lands and premises described as Lot Three (3) of Block One (1) District Lots One hundred and twenty one (121) and One hundred and eighty seven (187), Group One (1), New Westminster District, Map No. 1354. to the said Catherine Maudsley, and to deliver such conveyance when so executed to the said Catherine Maudsley.

2. This By-law may be cited as "Burnaby Property Exchange By-law No. 1, 1941."
