

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1742.

A BY-LAW to authorise the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor other lands in the Municipality.

WHEREAS the Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as Lot Forty five (45) of subdivision of Lot One (1) to Twelve (12) inclusive of Block numbered One (1) of District Lot numbered Seventy four South half (74 S.½) Map No. 1547 and Lot numbered One (1) of Block numbered Twenty four (24) of subdivision of District Lot numbered One hundred and Twenty one (121) Map No. 1054 all in Group One (1) New Westminster District.

AND WHEREAS Alfred W. McLeod Limited is the owner of lands and premises described as Lot Twenty five (25) of subdivision of Lot numbered Seven (7) of Block numbered Five (5) to Nine (9) inclusive of District Lot numbered Ninety six (96) Group One (1) Map No. 1194. New Westminster District.

AND WHEREAS the said Alfred W. McLeod Limited has requested the Corporation to convey to them the said lands described as Lot numbered Forty five (45) of subdivision of Lots numbered One (1) to Twelve (12) inclusive of Block numbered One (1) of District Lot numbered Seventy four South half (74 S.½) Group One (1) Map No. 1547 and Lot numbered One (1) of Block numbered Twenty four (24) of subdivision of District Lot numbered One hundred and Twenty one (121) Group One (1) Map No. 1054 New Westminster District and to accept in full payment therefor Conveyance of said Lot Twenty five (25) of subdivision of Lot numbered Seven (7) of Block numbered Five (5) to Nine (9) inclusive of District Lot numbered Ninety six (96) Group One (1) Map No. 1194 New Westminster District together with the sum of Forty (\$40.00) dollars of lawful money of Canada.

AND WHEREAS the Commissioner for the Corporation of the District of Burnaby deems it expedient to effect such exchange of lands.

THE COMMISSIONER for the Corporation of the District of Burnaby therefore ENACTS as follows:

1. Upon the execution and delivery to the Corporation of the District of Burnaby by Alfred W. McLeod Limited of a good and sufficient deed of the lands and premises described as Lot numbered Twenty five (25) of subdivision of Lot numbered Seven (7) of Block numbered Five (5) to Nine (9) inclusive of District Lot numbered Ninety six (96) Group One (1) Map No. 1194 New Westminster District free and clear of all encumbrance whatsoever, together with the sum of Forty (\$40.00) dollars of lawful money of Canada the Commissioner and Clerk of the Corporation are hereby authorized and empowered to execute and set the official and Corporate Seal of the Corporation of the District of Burnaby to a Conveyance of lands and premises described as Lot numbered Forty five (45) of subdivision of Lots numbered One (1) to Twelve (12) of Block numbered One (1) of District Lot numbered Seventy four South half (74 S.½) Group One (1) Map No. 1547 and Lot numbered One (1) of Block numbered Twenty four (24) of subdivision of District Lot numbered One hundred and Twenty One (121) Group One (1) Map No. 1054 New Westminster District to the said Alfred W. McLeod Limited, and to deliver such conveyance when so executed to the said Alfred W. McLeod Limited.

2. This By-law may be cited as "Burnaby Property Exchange By-law No. 2, 1941.
