THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 1754.

A BY-LAW to restrict the use of Firearms in the Municipality of Burnaby, in the Province of British Columbia.

The Commissioner of the Corporation of the District of Burnaby in exercise of all the powers him thereunto enabling enacts as follows:

(1) No person or persons shall discharge any rifle, except as provided in Clause 4, within the Municipal boundaries of the Corporation of the Municipality of Burnaby.

(2) Without limiting the application of Clause 1 hereof, no person or persons shall fire or discharge any gun, fowling piece or other firearm within the limits of the following areas of the Municipality of Burnaby:-

(a) That portion of North Burnaby bounded as follows:commencing at the corner of Boundary Road and 1st Avenue, thence in an easterly direction along 1st Avenue to Gilmore Avenue, thence northerly along Gilmore Avenue to Parker Street; thence easterly along Parker Street to Willingdon Avenue; thence northerly along Willingdon Avenue to Union Street; thence easterly along Union Street to Howard Avenue; thence northerly along Howard Avenue to Hastings Street; thence easterly along Howard Avenue to Burrard Avenue; thence in a northerly direction along Burrard Avenue to Burrard Avenue to Burrard Inlet; thence westerly along the Shore of Burrard Inlet to Boundary Road; thence southerly along Boundary Road to the point of commencement.

(b) That further portion of the Municipality of
Burnaby bounded as follows:- commencing at the corner of
10th Avenue and Cumberland Road; thence north-westerly
along Cumberland Road to 16th Avenue; thence south-westerly

along 16th Avenue to 1st Street; thence along 1st Street North westerly to 18th Avenue; thence south-westerly along 18th Avenue to 4th Street; thence north-westerly along 4th Street to 19th Avenue; thence south-westerly along 19th Avenue to 6th Street; thence north-westerly along 6th Street to Richmond Street; thence south-westerly along Richmond Street to Douglas Road; thence north-westerly along Douglas Road to Sperling Avenue; thence northerly along Sperling Avenue to the Burnaby Lake Branch of the B. C. Electric Railway; thence north-westerly along the said Railway to Royal Oak Avenue; thence southerly along Royal Oak Avenue to Glen Street; thence westerly along Glen Street to Willingdon Avenue; thence northerly along Willingdon Avenue to Moscrop Street; thence westerly along Moscrop Street to Boundary Road; thence southerly along Boundary Road to Rumble Street; thence easterly along Rumble Street to Patterson Avenue; thence southerly along Patterson Avenue to Marine Drive; thence easterly along Marine Drive to Gilley Avenue; thence northerly along Gilley Avenue to the Central Park Line of the B. C. Electric Railway; thence easterly and southerly along the said Railway Line to its. intersection with 20th Street; thence south-easterly along 20th Street to 10th Avenue; thence north-easterly along 10th Avenue and the New Westminster City Boundary to the point of commencement at Cumberland Road.

(c) Any dedicated park within the limits of the Municipality of Burnaby.

(3) In the remaining portions of the Municipality of Burnaby, no person or persons shall discharge any shotgun within 150 yards of any dwelling-house, schoolhouse, church, workshop or place of business, or of any highway or place where other persons may be assembled or engaged in work of any kind.

(4) The provisions of this By-law shall not apply to Police Constables, Game Wardens or bona fide householders of the Muni-

cipality of Burnaby or to members of their family or employees residing in family with them to prevent them from using firearms in accordance with the Provisions of the "Game Act", to shoot wild animals or birds, for protection of their stock or crops on their own lands, nor shall it apply to such persons nor to members of any rifle club or military unit while shooting on any recognized range or in course of drill, or at any private range approved by the police authorities of the Muncipality of Burnaby.

(5) Any person guilty of an infraction of this By-law shall, upon conviction thereof before the Police Magistrate having jurisdiction within the Municipality of Burnaby aforesaid, forfeit and pay at the discretion of the said Police Magistrate convicting a fine or penalty not exceeding the sum of One hundred dollars and costs for each offence and in default of payment thereof forthwith, it shall be lawful for such Police Magistrate convicting as aforesaid to issue a warrant under his hand and Seal to levy the said fine or penalty and cost or costs only by distress and sale of the offender's goods and chattels; and in case of no sufficient distress found to satisfy the said fine or penalty, it shall and may be lawful for the Police Magistrate convicting as aforesaid to commit the offender to prison for any period not exceeding thirty days (with or without hard labour) unless the said fine or penalty be sooner paid.

(6) By-law No. 116, being the "Burnaby Firearms Regulation By-law 1911" and all amendments thereto are each and every one of them hereby repealed.

(7) This By-law shall not come into force and effect unless and until it has received the approval of the Lieutenant-Governor in Council as required by law.

(8) This By-law may be cited for all purposes as the "BURNABY FIREARMS REGULATION BY-LAW 1941."
