CORPORATION OF THE DISTRICT OF BURNABY
BY-LAW NO. 1762.

A BY-LAW to acquire lands within the Municipality of Burnaby.

WHEREAS under the provisions of sub-section 17 of Section 59 of the "Municipal Act" the Municipal Council is authorised to make and pass By-laws to acquire or accept lands from any person for and to the use of the municipality.

AND WHEREAS it is desirable and expedient that a .35 action portion of Block 12, District Lot 10, Group 1, New Westminster District in the Municipality of Burnaby as shown on a plan attached hereto should be accepted from the Surviving Executors of the Estate of Levi Webster Stone, deceased.

AND WHEREAS the price to be paid to the Surviving Executors of the said Estate does not exceed the sum of Two thousand dollars.

THEREFORE the Commissioner for the Corporation of the District of Burnaby ENACTS as follows:

- 1. 0.35 acre portion of Block 12, District Lot 10, Group 1, New Westminster District, as shown on a plan attached hereto shall be acquired from William Ross Stone, of Vanderhoof, in the Province of British Columbia, and Clifford Ervin Stone, of Ioco, in the Province of British Columbia, Surviving Executors of the Estate of Levi Webster Stone, deceased, for Corporate purposes.
- 2. On execution and delivery of conveyance of said parcel by the said William Ross Stone, and Clifford Ervin Stone, to the Corporation of the District of Burnaby they shall be paid the sum of One (\$1.00) dollar.

- 3. This By-law shall take effect upon registration thereof.
- 4. This By-law may be cited for all purposes as "BURNABY LAND ACQUISITION BY-LAW 1942."
