

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1785.

A BY-LAW to authorize the Commissioner for The Corporation of the District of Burnaby to repay to Winnifred M. D. Trembath the sum of One Hundred and Fifty Dollars.

WHEREAS the Corporation of the District of Burnaby by By-law No. 1770 authorized the sale of Lot Five (5) of Block Thirty (30) of Subdivision of District Lot Sixty-nine (69), Group One (1), New Westminster District, Map No. 1321 to Winnifred M. D. Trembath, for the sum of Three hundred (\$300.00) dollars.

AND WHEREAS the said Winnifred M. D. Trembath has paid to the Corporation the sum of One Hundred and Fifty (\$150.00) dollars towards the payment for the said lands.

AND WHEREAS the said Winnifred M. D. Trembath is unable to complete the said purchase, and has executed a release and reconveyance to the Corporation of all or any claims, right, title or interest in the said property in consideration of the Corporation agreeing to repay to her the said sum of One Hundred and Fifty (\$150.00) dollars.

AND WHEREAS by Order-in-Council No. 1220 approved on the Eleventh (11th) day of September, A.D. 1942, power is given to the Commissioner for The Corporation of the District of Burnaby to pass a by-law providing for the repayment of the aforesaid sum of One Hundred and Fifty (\$150.00) dollars to the said Winnifred M. D. Trembath.

THEREFORE the Commissioner for the Corporation of District of Burnaby ENACTS as follows:-

1. That the Corporation of the District of Burnaby be and

is hereby authorized to accept from Winnifred M. D. Trembath a release and reconveyance of all and singular that certain parcel or tract of land and premises situate, lying, and being in the Municipality of Burnaby, Province of British Columbia, and being composed of Lot Five (5) of Block Thirty (30) of Subdivision of District Lot Sixty nine (69), Group One (1), New Westminster District, Map No. 1321.

2. That upon delivery of the said release and reconveyance of the said hereinbefore described property by the said Winnifred M. D. Trembath to the Corporation, the Commissioner, be and is hereby authorized to repay to the said Winnifred M. D. Trembath the sum of One Hundred and Fifty (\$150.00) Dollars.

3. This By-law may be cited as the "TREMBATH REPAYMENT BY-LAW 1942."
