

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1797

A BY-LAW to authorise the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby

WHEREAS the Corporation of the District of Burnaby has acquired through tax sale proceedings certain lands situate within the Municipality, namely, Lots One (1), Three (3), Four (4), Five (5), Six (6), and Fifteen (15) to Twenty (20) inclusive, of Block Eleven (11) in the Subdivision of District Lot One hundred and seventy three (173) Group One (1) New Westminster District, according to the registered map or plan of the said subdivision deposited in the Land Registry Office in the City of New Westminster and therein numbered 1034.

AND WHEREAS pursuant to Section 504 of the "Municipal Act" The Corporation of the District of Burnaby has by Order in Council No. 16. approved on the 5th day of January, A.D. 1943, been authorised to sell and dispose of the said lands to Wesley William McLeod, Dairyman, Elsona, P.O. B.C. and Phoebe Harriet Scott, wife of William B. Scott, of 1775 Britton Street, Burnaby, B.C. Administrators with the Will annexed of the Estate of John Wesley McLeod, deceased, for the sum of \$2,144.43

AND WHEREAS the said sum of \$2,144.43 has been paid to the Corporation.

THE MUNICIPAL COUNCIL of the Corporation of the District of Burnaby therefore enacts as follows:

1. That all and singular those certain parcels or tracts of lands and premises situate, lying and being in the Municipality of Burnaby, District of New Westminster, Province of British Columbia, and being more particularly described as Lots numbered One (1), Three (3), Four (4), Five (5), Six (6) and Fifteen (15) to Twenty (20) inclusive, of Block Eleven (11) in subdivision of District Lot One

hundred and seventy three (173) Group One (1) Map No. 1034. be sold and disposed of to Wesley William McLeod, Dairyman, Elsona, P.O. B.C. and Phoebe Harriet Scott, wife of William B. Scott, of 1775 Britton Street, Burnaby, B.C. for the sum of Two thousand, one hundred and forty four dollars and forty three cents (\$2,144.43), and that a conveyance to the said Wesley William McLeod, and Phoebe Harriet Scott, be executed under the Seal of the Corporation by the Reeve and Clerk, and be delivered to the said purchasers.

2. This By-law may be cited as "BURNABY LAND SALE BY-LAW NO.1. 1943"
