

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1822

A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor other lands in the Municipality

WHEREAS the Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as South half of Lot Nineteen (19S $\frac{1}{2}$ ) subdivision of Blocks Forty eight (48) to Fifty (50) inclusive, District Lot Thirty three (33) Group One (1) New Westminster District, Map No. 1338.

AND WHEREAS Laurence Knight Ryan and Caroline Kendall Ryan (wife of Laurence Knight Ryan) both of 3607 Elson Avenue, in the Municipality of Burnaby Province of British Columbia, are the owners of lands and premises described as the North half of Lot Twenty (20N $\frac{1}{2}$ ) in subdivision of Blocks Forty-eight (48) to Fifty (50) inclusive, District Lot Thirty-three (33) Group One (1) New Westminster District, Map No. 1338.

AND WHEREAS the said Laurence Knight Ryan and Caroline Kendall Ryan have requested the Corporation to convey to them the said lands described as the South half of Lot nineteen (19S $\frac{1}{2}$ ) in subdivision of Blocks Forty eight (48) to Fifty (50) inclusive, District Lot Thirty three (33) Group One (1) New Westminster District, Map No. 1338, and to accept in full payment therefor conveyance of the said North half of Lot Twenty (20N $\frac{1}{2}$ ) of subdivision of Blocks Forty eight (48) to Fifty (50) inclusive, District Lot Thirty three (33) Group (1) New Westminster District, Map No. 1338.

AND WHEREAS it is deemed advisable to effect such exchange of lands and premises.

THEREFORE the Council of the Corporation of the District of Burnaby ENACTS as follows:

1. Upon the execution and delivery to the Corporation of the District of Burnaby by Laurence Knight Ryan and Caroline Kendall Ryan of a good and sufficient deed of the lands and premises described as the North half of Lot Twenty (20N $\frac{1}{2}$ ) of subdivision of Blocks Forty eight (48) to Fifty (50) inclusive District Lot Thirty three (33) Group One (1) New Westminster District, Map No. 1338, free and clear of all encumbrance whatsoever, the Reeve and the Clerk are hereby authorised and empowered to execute and set the official and Corporate seal of the Corporation of the District of Burnaby to a Conveyance of lands and premises described as South half of Lot Nineteen (19S $\frac{1}{2}$ ) of subdivision of Blocks Forty eight (48) to Fifty (50) inclusive, District Lot Thirty three (33) Group One (1) New Westminster District Map No. 1338, to the said Laurence Knight Ryan and Caroline Kendall Ryan, and to deliver such Conveyance when so executed to the said Laurence Knight Ryan and Caroline Kendall Ryan.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 1. 1943."
