THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 1858

A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor other lands in the Municipality.

WHEREAS the Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as West half of Lot Fifteen (15) of Block Thirty seven (37) of District Lot One hundred and Fifty one (151) and One hundred and Fifty three (153), Group One (1), New Westminster District, Map No. 2069.

AND WHEREAS Alfred Nuttall and Florence Hypatia
Nightingale Nuttall (wife of Alfred Nuttall) both of 4318 Trafalgar
Street in the Municipality of Burnaby and Province of British
Columbia, are the owners of lands and premises described as Lot
Twelve (12) of Blocks Forty seven (47) and Forty nine (49) of
District Lot One hundred and Fifty one (151) to One hundred and
Fifty three (153), Group One (1), New Westminster District, Map
No. 1936.

AND WHEREAS the said Alfred Nuttall and Florence Hypatia Nightingale Nuttall have requested the Corporation to convey to them the said lands described as West half of Lot Fifteen (15) of Block Thirty seven (37) of District Lot One hundred and Fifty one (151) to One hundred and Fifty three (153) Group One (1), New Westminster District, Map No. 2069 and to accept in full payment therefor Conveyance of Lot Twelve (12) of Blocks Forty seven (47) and Forty nine (49) of District Lot One hundred and Fifty one (151) to One hundred and Fifty three (153), Group One, New Westminster District, Map No. 1936 together with the sum of Sixty (\$60.00) dollars.

AND WHEREAS it is deemed advisable to effect such exchange of lands and premises.

THEREFORE the Council of the Corporation of the District of Burnaby ENACTS as follows:

- 1. Upon the execution and delivery to the Corporation of the District of Burnaby by Alfred Nuttall and Florence Hypatia Nightingale Nuttall of a good and sufficient deed of the lands and premises described as Lots Twelve (12) of Blocks Forty seven (47) and Forty nine (49) of District Lot One Hundred and Fifty one (151) to One hundred and fifty three (153), Group One (1) New Westminster District, Map No. 1936, free and clear of all encumbrance whatsoever, together with the sum of Sixty (\$60.00) dollars, the Reeve and the Clerk are hereby authorised and empowered to execute and set the official and Corporate Seal of the Corporation of the District of Burnaby to a Conveyance of lands and premises described as West half of Lot Fifteen (15) of Block Thirty seven (37) of District Lot One hundred and Fifty one (151) to One hundred and fifty three (153), Group One (1) New Westminster District, Map No. 2069, to the said Alfred Mutall and Florence Hypatia Nightingale Nuttall, and to deliver such Conveyance when so executed to the said Alfred Nuttall and Florence Hypatia Nightingale Nuttall.
- 2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO.1. 1944.
