THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1862.

A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor other lands in the Municipality.

WHEREAS the Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as East half of Lot Fifteen (15) of Block Thirty-seven (37) of District Lot One hundred and Fifty one (151) to One hundred and Fifty three (153), Group One (1), New Westminster District, Map No. 2069.

AND WHEREAS James Stewart of 59 East 7th Avenue in the City of Vancouver and Province of British Columbia is the owner of lands and premises described as Lot Twenty two (22) of Block Twenty one (21) of District Lot Sixty eight (68), Group One (1), New Westminster District, Map No. 1009.

AND WHEREAS the said James Stewart has requested the Corporation to convey to him the said lands described as East half of Lot Fifteen (15) of Elock Thirty-seven (37) of District Lot One hundred and Fifty one (151) to One hundredaand Fiftythree (153), Group One (1), New Westminster District, Map No. 2069 and to accept in full payment therefor Conveyance of Lot Twenty two (22) of Elock Twenty one (21) of District Lot Sixtyeight (68), Group One (1), New Westminster District, Map No. 1009 together with the sum of Two hundred and Fifteen (\$215.00) dollars.

AND WHEREAS it is deemed advisable to effect such exchange of lands and premises.

THEREFORE the Council of the Corporation of the District of Burnaby ENACTS as follows:

1. Upon the execution and delivery to the Corporation of the District of Burnaby by James Stewart of a good and sufficient deed of lands and premises described as Lot Twenty two (22)

of Block Twenty-one (21) of District Lot Sixty eight (68), Group One (1), New Westminster District, Map No. 1009, free and clear of all encumbrance whatsoever, together with the sum of Two hundred and Fifteen (\$215.00) dollars, the Reeve and the Clerk are hereby authorised and empowered to execute and set the official and Corporate Seal of the Corporation of the District of Burnaby to a Conveyance of lands and premises described as East half of Lot Fifteen (15) of Block Thirtyseven (37) of District Lot One hundred and Fifty one (151) to One hundred and Fifty three (153), Group One (1), New Westminster District, Map No. 2069, to the said James Stewart and to deliver such Conveyance when so executed to the said James Stewart.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 1, 1945."
