

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1875

A By-law to authorize the sale to William Parker Crowley of Lot Eight (8) of Block Eighteen (18) of District Lot One hundred and Twenty-one (121) Group One (1) New Westminster District.

WHEREAS the lands hereinafter mentioned were acquired by the Corporation of the District of Burnaby from Margaret Jane Patton, personal representative of Albert Patton deceased, under authority of By-law No. 763 of the Corporation.

EBB AND WHEREAS William ^{Patrick} Parker Crowley, Sign~~al~~man, of 4248 Frances Street in the Municipality of Burnaby, Province of British Columbia, has offered to purchase the said lands for the sum of One thousand Two hundred and Fifty (\$1,250.00) dollars on terms hereinafter mentioned and it is desirable to accept the said offer.

NOW THEREFORE the Municipal Council of the Corporation of the District of Burnaby ENACTS as follows:-

1. That Lot Eight (8) of Block Eighteen (18) of District Lot One hundred and Twenty-one (121) Group One (1) New Westminster District, Map No. 1054, shall be sold to William ^{Patrick} Parker Crowley, *EBB* Sign~~al~~man, of 4248 Frances Street in the Municipality of Burnaby, Province of British Columbia, for the sum of One thousand Two hundred and Fifty (\$1,250.00) dollars payable as follows:-

Three hundred and Fifty (\$350.00) dollars on the execution and delivery of the Agreement for Sale hereinafter mentioned.

The Sum of Twenty (\$20.00) dollars on the First (1st) day of August, 1929 and on the First (1st) day of each and every month thereafter, with interest on the purchase money from time to time remaining unpaid at the rate of Six (6%) per cent. per annum with each instalment.

2. An agreement for sale and purchase of the said lands in the terms hereinbefore mentioned shall be executed under the seal of the Corporation by the Reeve and Clerk.

3. Upon payment by the purchaser of the purchase money aforesaid and on compliance with the terms of the said Agreement for Sale, Conveyance of the said lands shall be executed under the Corporation

seal of the Corporation of the District of Burnaby by the Reeve and Clerk and delivered to the said William ^{Patrick} Parker Crowley. *BBB*

4. This By-law shall take effect on its being finally passed.

5. This By-law may be cited as "PATTON LAND SALE BY-LAW 1945."
