## CORPORATION OF THE DISTRICT OF BURNABY

## BY-LAW NO. 1880

A BY-LAW to acquire certain lands within the Municipality of Burnaby and to dedicate the same and other lands for street allowances within the Municipality of Burnaby.

WHEREAS under the provisions of sub-section 217 of Section 59 of the Municipal Act being Chapter 199 of the Revised Statutes of British Columbia, 1936, the Municipal Council is authorised to make by-laws for establishing, opening, widening, altering, diverting, or stopping up roads, streets, squares, lanes, bridges, or other public thoroughfares.

AND WHEREAS it is desirable and expedient that certain lands should be acquired for road purposes and that certain lands should be dedicated for the purpose of street allowance in the Municipality of Burnaby.

THEREFORE the Council of the Corporation of the District of Burnaby ENACTS as follows:-

- 1. That the following parcels of land all in Group One (1), New Westminster District, shall be and are hereby dedicated for street purposes, that is to say:
  - (a) The west thirty three (33') feet of the North one-half of Block Twenty eight (28) District Lot Thirty two (32) Map No. 812.
  - (b) The north thirty three (33') feet of the East one-half of Lot Twelve (12) District Lot One hundred and thirty one (131), Map No. 3052.
  - (c) Lot Eight (8) of Block Thirty one (31) of Subdivision of Lots one and three (1 & 3) of District Lot Ninety five (95) Map No. 1915, save and except part (0.16 of an acre) shewn on sketch deposited and numbered 9475.
  - (d) Lot One (1) of Blocks Thirty four (34), Thirty-five (35) and Thirty six (36) of Lot Thirty-five (35) Map No. 1370 save and except part (0.472 of an acre) heretofore conveyed shewn on Sketch deposited and numbered 9641.
  - (e) Lot Four (4) of Block Eleven (11) District Lot Ninety seven (97) Map No. 2802 save and except part (0.148 of an acre) shewn on sketch deposited and numbered 9504.

- (f) West half of Lot Ten (10) of Block ten (10) subdivision of North half of District Lot One hundred and sixteen (116), Map No. 1236, save and except part (0.059 of an acre) shewn on sketch deposited No. 9560.
- (g) Southerly thirty three (33') feet of Block Eight (8) of District Lot Eleven (11), Map No. 3045, said Southerly thirty three (33') feet having a frontage of thirty three (33') feet on Coldicutt Street and adjoining Lots Seven (7) and Nine (9).
- 2. All and singular that certain parcel or tract of land and premises situate lying and being in the Municipality of Burnaby, in the District of New Westminster, in the Province of British Columbia, and being composed of the East thirty three (33') feet of Block numbered One hundred and nineteen (119) of subdivision of District Lot numbered Ninety two (92), Group One (1), Map No. 1146, shall be acquired from Rene Pierre Morin and Anne Marie Morin (wife of Rene Pierre Morin) of 12003 97th Street in the City of Edmonton, in the Province of Alberta, for the purpose of widening the road allowance of Ashworth Avenue in the Municipality of Burnaby.
- 3. That on execution and delivery of conveyance by the said Rene Pierre Morin and Anne Marie Morin to the Corporation of the District of Burnaby of the said East thirty three (33') feet of Block One hundred and nineteen (119), District Lot Ninety two (92) Group One (1), Map No. 1146 they shall be paid the sum of One dollar (\$1.00)
- 4. The said East thirty three (33') feet of Block one hundred and nineteen (119), District Lot Ninety two (92), Group One (1), Map No. 1146 New Westminster District, shall be and is hereby dedicated for street purposes.
- 5. This By-law may be cited as "Burnaby Land Acquisition and Street Dedication By-law 1945."
