

CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1890

A BY-LAW to acquire certain lands and improvements within the Municipality of Burnaby and to dedicate the same for Park purposes.

WHEREAS the South Burnaby Recreational Centre have requested the Corporation of the District of Burnaby to accept a Conveyance of lands and premises described as part 0.347 of an acre more or less of Block 24 of Lot 32, Group 1, Map 812, and of Block 32 of Lot 152, Group 1, Map 783, as shewn outlined red on Sketch 9382, all in the Municipality of Burnaby, District of New Westminster, Province of British Columbia, paying therefor the sum of Two Thousand Dollars (\$2000.00).

AND WHEREAS it is deemed desirable and expedient that the said lands and improvements thereon should be acquired by the Corporation of the District of Burnaby for Park purposes.

THEREFORE the Municipal Council of the Corporation of the District of Burnaby ENACTS as follows:-

1. That ALL AND SINGULAR that certain parcel or tract of lands and premises situate, lying and being in the Municipality of Burnaby, Province of British Columbia being more particularly described as

Part 0.347 of an acre more or less of Block Twenty-four (24) of Lot Thirty two (32) Group One (1), Map No. 812, AND of Block Thirty-two (32) of Lot One hundred and fifty-two (152), Group One (1), Map No. 783 as shewn outlined red on Sketch 9382, District of New Westminster.

be acquired by the Corporation of the District of Burnaby for Park purposes.

2. That upon delivery of a Conveyance of the said lands to the Corporation of the District of Burnaby, free and clear of all encumbrance the South Burnaby Recreational Centre shall be paid the sum of Two Thousand (\$2000.00) Dollars.

3. There is hereby defined and set apart for Park purposes all of the lands described as ALL AND SINGULAR that certain parcel or tract of lands and premises situate, lying and being in the Municipality of Burnaby, Province of British Columbia being more

particularly described as

Part 0.347 of an acre more or less of Block Twenty-four (24) of Lot Thirty two (32) Group One (1), Map No. 812, AND of Block Thirty-two (32) of Lot One hundred and fifty two (152) Group One (1), Map No. 783, as shewn outlined RED on Sketch 0382, District of New Westminster.

4. This By-law shall come into effect on the date of registration thereof.

5. This By-law may be cited for all purposes as "BURNABY LAND ACQUISITION AND PARK DEDICATION BY-LAW 1945"

RECONSIDERED AND FINALLY PASSED by a three-fourths majority of the Municipal Council on the Twenty-second (22nd) day of October, A.D. 1945.
