THE CORPORATION OF THE DISTRICT OF BURNABY BY-LAW NO. 1898

A BY-LAW to define and set aside certain lands within the Municipality of Burnaby for Park purposes.

whereas by paragaph (d) of sub-section 179 of Section 59 of the "Municipal Act" it is provided that in every Municipality the Council may, by By-law finally passed by a three fourths vote of all members thereof, and without obtaining the assent of the electors, define an area comprising lands that have become the property of the Municipality through tax sale proceedings and set aside such area for park purposes, for recreation grounds, or school sites, or for other public purposes.

AND WHEREAS lands described as All and Singular that certain parcel or tract of land and premises situate lying and being in the Province of British Columbia, Municipality of Burnaby and being more particularly described as Lots Thirty Seven (37) to Fifty Four (54) inclusive of Block Nine (9) of District Lot Eighty Seven (37), Group One (1), Map One thousand eight hundred and forty five (1845), Lots Seventy seven (77) to Eighty four (84) inclusive, of Blocks Seven (7) and Eight (8) of District Lot Eighty Seven (87), Group One (1), Map One thousand six hundred and seventy two (1672), Lots Eighty six (86) to Ninety seven (97) inclusive of Blocks Seven (7) and Eight (8) of District Lot Eighty Seven (87), Group One (1), Map One thousand six hundred and seventy two (1672), in the District of New Westminster, became the property of the Corporation of the District of Burnaby under the provisions of paragraph (2) of Section 273 of the Municipal Act:

AND WHEREAS lands described as All and Singular that certain parcel or tract of land and premises situate lying and being in the Province of British Columbia, Municipality of Burnaby and being more particularly described as Lot Eighty five (85) of Blocks Seven (7) and Eight (8) of District Lot Eighty Seven (87), Group One (1), Map One thousand six hundred and seventy two (1672) was acquired by the Corporation of the District of Burnaby for Corporate purposes, and is no longer required for the purpose for which it was acquired.

AND WHEREAS it is considered expedient and in the public interest that the said lands in the Municipality of Burnaby should so set aside for park purposes:

THEREFORE the Municipal Council of the Corporation of the District of Burnaby ENACTS as follows:-

1. There is hereby defined and set apart for park purposes all of the lands and premises situate lying and being in the Province of British Columbia, in the Municipality of Burnaby and being more particularly described as

Lots Thirty Seven (37) to Fifty Four (54) inclusive of Block Nine (9) of District Lot Eighty Seven (87), Group One (1), Map One thousand eight hundred and forty five (1845), Lots Seventy seven (77) to Eighty four (84) inclusive of Blocks Seven (7) and Eight (8) of District Lot Eighty Seven (87), Group One (1), Map One thousand six hundred and seventy two (1672), Lot Eighty five (85) of Blocks Seven (7) and Eight (8) of District Lot Eighty Seven (87), Group One (1), Map One thousand six hundred and seventy two (1672), Lots Eighty six (86) to Ninety seven (97) inclusive of Blocks Seven (7) and Eight (8) of District Lot Eighty Seven (87), Group One (1), Map One thousand six hundred and seventy two (1672) all in the District of New Westminster

2. This By-law may be cited as "BURNABY PARK DEDICATION BY-LAW No. 3, 1945."
