

THE CORPORATION OF THE DISTRICT OF BURNABY

BY-LAW NO. 1901

A BY-LAW to authorize the sale of certain Tax Sale lands belonging to the Corporation of the District of Burnaby, and to accept in part or full payment therefor, other lands in the Municipality.

WHEREAS the Corporation of the District of Burnaby has acquired under Tax Sale proceedings, lands and premises described as Lots One (1) and Two (2) subdivision of Block Five (5), District Lot One hundred Eighty Seven (187) Group One (1) New Westminster District, Map No. 1282.

AND WHEREAS Hugh Smith, Mechanic, of 4490 Triumph Street in the Municipality of Burnaby, Province of British Columbia, is the owner of lands and premises described as Lot Twenty six (26), of Block Twenty six (26), of Block "C", of District Lot One hundred and Eighty eight (188), Group One (1), New Westminster District, Map No. 1475.

AND WHEREAS the said Hugh Smith has requested the Corporation to convey to him the said lands described as Lots One (1) and Two (2), Subdivision of Block Five (5), District Lot One hundred Eighty Seven (187), Group One (1), New Westminster District, Map No. 1282, and to accept in full payment therefor conveyance of the said Lot Twenty six (26), of Block Twenty six (26), of Block "C", of District Lot One hundred and Eighty eight (188), Group One (1), New Westminster District, Map No. 1475.

AND WHEREAS it is deemed advisable to effect such exchange of lands and premises.

THEREFORE the Council of the Corporation of the District of Burnaby ENACTS as follows:

1. Upon the execution and delivery to the Corporation of the District of Burnaby by Hugh Smith of a good and sufficient deed of the lands and premises described as Lot Twenty six (26) of Block Twenty six (26), of Block "C", of District Lot One hundred and Eighty eight (188), Group One (1), New Westminster District, Map No. 1475, free and clear of all encumbrance

whatsoever, the Reeve and the Clerk are hereby authorized and empowered to execute and set the official and Corporate Seal of the Corporation of the District of Burnaby to a Conveyance of lands and premises described as Lots One (1) and Two (2), of subdivision of Block Five (5), of District Lot One hundred and eighty seven (187), Group One (1), New Westminster District, Map No. 1282, to the said Hugh Smith, and to deliver such Conveyance when so executed to the said Hugh Smith.

2. This By-law may be cited as "BURNABY PROPERTY EXCHANGE BY-LAW NO. 1, 1946."
